



HIAWATHA INSIGHTS

At times we receive questions regarding what a Hiawatha resident can expect to pay in property taxes. Although this seems like a straightforward question, there are many factors that determine residential property taxes and each factor varies from year to year. Some of the variables include: the assessed value of the property as determined by the Linn County Assessor’s Office; the State mandated rollback factor on residential property that changes yearly; and, the levy rate of all of the taxing entities called a consolidated tax levy rate. The following demonstrates the process of equating a residential property with an assessed value of \$200,000 for fiscal year 2023 taxes payable:

It is often incorrectly assumed that the entire amount of property taxes paid is going to the City. The rate is actually made up of seven different jurisdictional levies. In Hiawatha, these include: the Cedar Rapids Community School District, the City of Hiawatha, Linn County, Kirkwood Community College, Linn County Assessor, Ag Extension and the State of Iowa. The following table shows the percentage of the total consolidated tax rate of each jurisdiction and the distribution of your property tax dollars for fiscal year 2023.

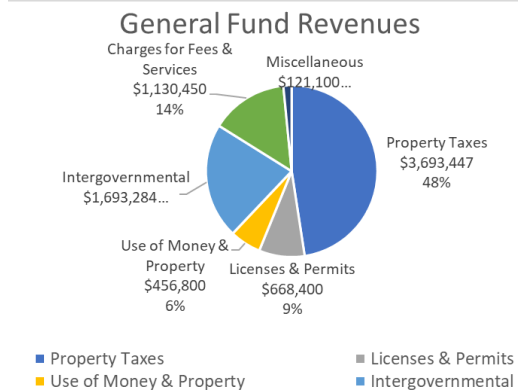
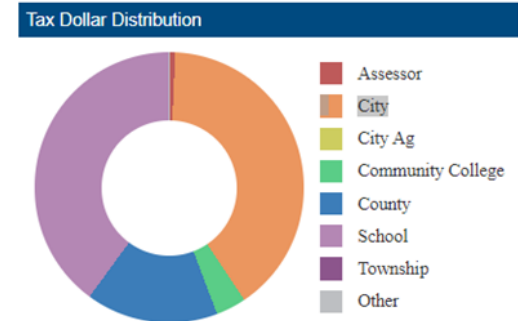

As you can see, the City of Hiawatha receives \$1,597 and approximately 40% of the property taxes you pay on a \$200,000 home. Property taxes provide the majority of the funding for Public Safety, Fire and Ambulance, Library, Park & Recreation, Community Development, Policy & Administration, and City Hall.

The City of Hiawatha has maintained or lowered our tax levy rate each year since 2016. Even with no change or little change in Hiawatha’s levy rate, homeowners could still see an increase in their property taxes due to an increase in the assessed value of their property, the taxable value as a result to the state residential rollback, a change in any of the other levies of the school district, county offices or Kirkwood Community College.

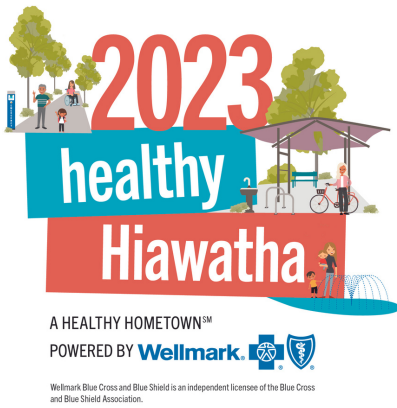

HIAWATHA, IA 52233 is expected to pay \$4,954 during the current 2022-2023 tax year.

### How long have you been Hiawatha’s City Attorney?

I was the assistant City Attorney from 2003–2007 and City Attorney from 2009–present.

### How would you summarize what you do?

I provide legal advice to the Mayor, City Council, City Manager, Directors, and city staff. I work in a variety of areas, including reviewing city ordinances, buying and selling city property, annexations, condemnations, contracts, and employment questions. If you see me at the Linn County courthouse, I could be prosecuting traffic citations or municipal infractions.

### What is your favorite part of working with the City of Hiawatha?

I live in Hiawatha, so it is rewarding to help the City function well. The work is interesting – new problems arise all the time. I enjoy working with the many talented people employed by the City and the elected officials. I am energized by working in teams, and Hiawatha has great teams. As the saying goes, we take our work seriously but not ourselves.

### What is one thing you wish people knew about your job?

I don’t make policies. I only provide legal advice about policies.

### What is the most unusual aspect of working with the City of Hiawatha?

I do see some interesting dashboard videos when I prosecute traffic violations.

### How has the City of Hiawatha changed since you started as the City Attorney?

A lot. Probably the biggest change I’ve experienced was the building of City Hall. Having city staff in one location and spacious meeting rooms allows the City to conduct its business efficiently. Citizens can come to one building for questions about their water bill, building permits, etc. and use the community center for social events. The momentum continues with the library renovations, creation of the City Center district, Tower Terrace interchange, and now the second fire station.

### What have you gained from working with the City of Hiawatha?

The work is interesting, so I am continually expanding my knowledge base. The best part of my position is the relationships I’ve formed with wonderful people.

## GOOD NEIGHBOR POLICY: PETS

We all know owning a pet is a big responsibility and how we handle and care for our pets can affect our neighbors and our community as a whole. Hiawatha has several ordinances which address barking, proper animal care, containment and sanitation located in Chapters 50 - Nuisances, Chapter 53 - Noise, Chapter 55 - Animal Protection, and Chapter 162 - Storm Water Discharge

If you were to search "barking dogs" on the internet you would soon realize, by the excess of articles, that a barking dog could cause major conflict between neighbors. Acts of violence against animals and their owners are frequently in the news.

As stated in previous articles, many of our ordinances deal with the practical matters of living peacefully side by side in our community, or "peaceful coexistence". This is certainly the case for our ordinances associated with owning a dog. If you were to search for "barking" in the City's noise ordinance you'd find no less than three Chapters dealing with this issue.

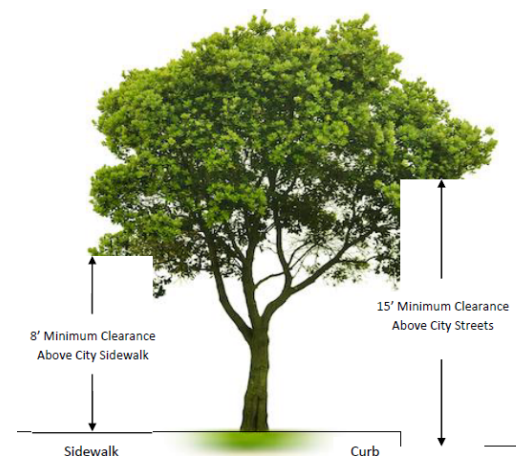
If the pet is not properly controlled, the City would take the necessary course of action with the Police Department or through Community Development. However, if the problem is not handled by the pet owners, it can damage our community aesthetics and reputation.

Controlling and cleaning up waste from pets is a common problem in most communities. All animal waste should be collected and deposited with other garbage to be properly disposed of. Our City ordinances make it clear that the owner is responsible for their pet's sanitation. If the animal waste is not properly disposed of, it can contaminate our streams, rivers and lakes. Ground water is a valuable resource which must be protected in order to maintain our clean water supply and natural water resources. With proper pet waste disposal, our water amenities can then be enjoyed by all without worry of disease and contamination.

Controlling loud animals and cleaning up their waste are common problems in most communities. This nuisance is difficult to control apart from the cooperation with our pet owners. Our ordinances make it clear that the owner is responsible for their pet. Be a good neighbor and care for your neighbors and fellow Hiawathans by caring for and controlling your pet.

## GOOD NEIGHBOR POLICY: TREES

Most city ordinances are enacted to facilitate citizens' living together in harmony. One such ordinance in Hiawatha is our tree ordinance #151. This ordinance describes how to manage and trim trees when they encroach on the public right of way. This picture illustrates the specific clearance requirements.

### HIAWATHA FIRE AND EMS EXPLORER PROGRAM

The Hiawatha Fire Department in a joint partnership with Learning for Life are bring the careers of firefighting and emergency medical services to life by offering youth participants an opportunity to learn about fire and emergency service firsthand.

Fire Explorers participate in non-hazardous activities that will familiarize participants with the functions and duties of emergency services. In addition to learning about fire and EMS, the main goal of the Explorer Program's is to provide young adults with a sense of responsibility to their community through ongoing community-based activities. Explorers will train in five areas of development: Career, Character, Service, Life Skills, and Leadership Experience. Explorers work under the immediate supervision of a Hiawatha Firefighter who is the Explorer Post Advisor. The organizational structure of the Explorer Post is similar to that of the Fire Department. This allows for the development of leadership skills and abilities to be nurtured and utilized within the young adults participating.

Duties that Explorers participate in include: participating in Fire and EMS drills and training, sets up and uses fire and EMS equipment, participates in public education and community outreach, and participate in the Explorer Ride-Along Program to learn about the duties of Firefighters and EMS Personnel at a firehouse.

The minimum requirements to become a member of the Hiawatha Fire and EMS Explorer Post are be at least 14 years of age (but not yet 21 years of age), be enrolled in school, be of good moral character and standing, and be willing to maintain the standards of the Hiawatha Fire and EMS Exploring Program.

### MOSQUITO CONTROL PROGRAM

Schendel Pest Control has been awarded the 2023 Mosquito Control contract. Mosquito spraying is done with an ultra-low volume machine from the back of a truck. Schendel will cover all accessible streets as well as city parks and recreation areas. The product being used is Sumithrin a synthetic pyrethroid. Natural pyrethrin comes from the chrysanthemum flower, making it safe for our city residents. 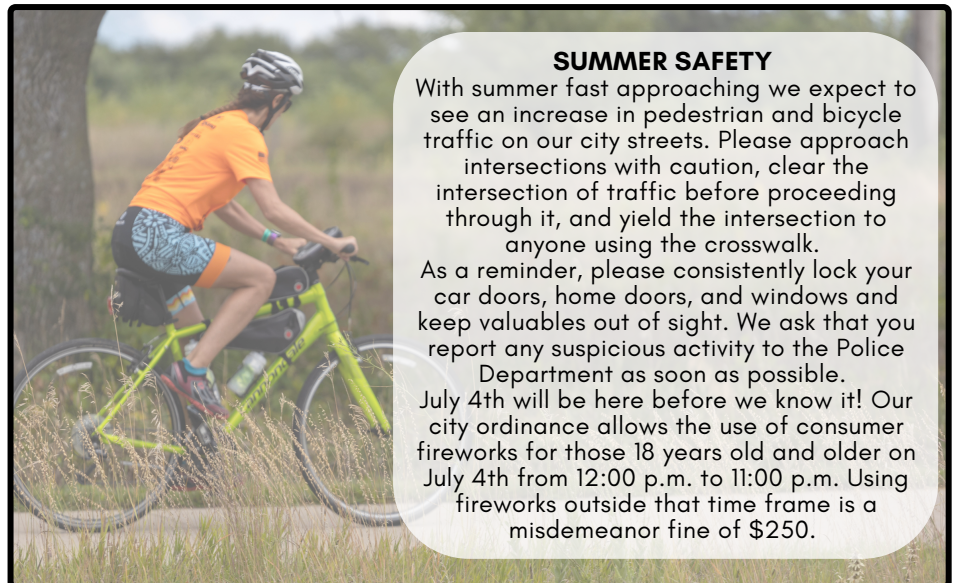
