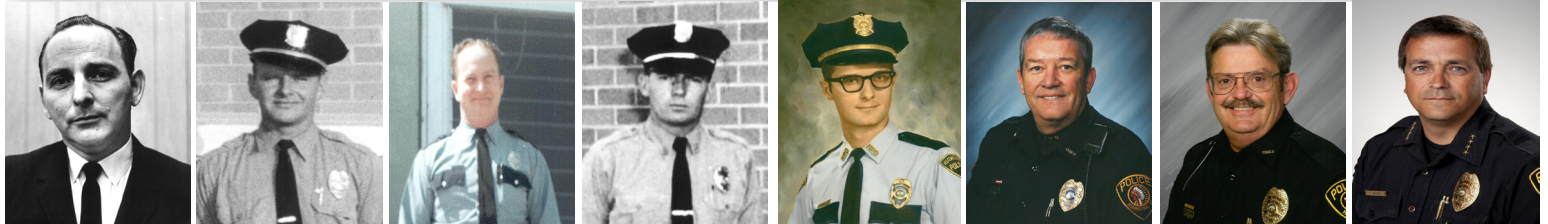


New P&Z Board Member

Hiawatha Economic Development Corporation (HEDCO), the City of Hiawatha, and Cedar Rapids Metro Economic Alliance hosted the first Business Summit of 2014. The Business Summit was co-hosted by Rud Chain and held in the Hiawatha Community Center at City Hall from 7:30 - 8:30 a.m. Members of the local business community had the opportunity to network and listen to owners/representatives of Hiawatha businesses talk about their products and services.

City Administrator Kim Downs and City Engineer John Bender also spoke about the importance of the Tower Terrace Road/I-380 to North Center Point Road Interchange project and provided an update on the status of the project which is scheduled to begin construction in 2017.



2014 Street Repair Project

The City of Hiawatha is planning a street repair project during the spring/summer of 2014 funded through the Capital Improvement Program. Council established a budget for design and reconstruction of two streets and a section of another street. The streets identified as high priority were:

- 14th Avenue from Cress Parkway to Rainbow Drive
- Eisenhower Street from 9th Avenue to 10th Avenue
- Emmons Street at the CC&P Railroad Tracks

Eisenhower and 14th Avenue are scheduled for total removal and replacement, as well as the additional items required for construction. These items include sanitary sewer repair, new storm sewer, new driveway approaches, and sidewalk ramps. The City has contracted for engineering plans, drawings, and specifications.

Bidding is proposed for in April with construction starting as soon as possible this spring of 2014. We have made every effort to minimize inconveniences to private property owners on 14th Avenue and Eisenhower; however there will be times when access to all driveways will not be possible. Contact the engineering department for more information regarding the construction schedule. The other street section, Emmons Street at the railroad crossing, will require close coordination with the CC&P Railroad where a new rubberized crossing was constructed in the fall of 2013. Coordination with the Iowa DOT is also anticipated as approach work or modifications to the Emmons Street/I380 Bridge are anticipated. This work is scheduled for later in the summer.



Dangerous Animals Ordinance Amended

The State amended Iowa Code Chapter 717F Dangerous Wild Animals approximately six years ago by removing the prohibition of all constrictor snakes. Instead, the State classified certain families of venomous and extremely volatile snakes as "Dangerous Wild Animals," and prohibited people from keeping or harboring these particular types of snakes. After the State amended their code, the cities of Cedar Rapids and Marion updated their dangerous animal code chapters to mirror the Iowa Code.

On February 19, 2014, Hiawatha City Council passed Ordinance #778 amending City Code Chapter 57 Dangerous and Vicious Animals. The Hiawatha City Code definitions of "Dangerous Animals" now mirrors the State of Iowa, City of Cedar Rapids, and Marion definitions of "Dangerous Wild Animals."

Temporary Embargo - Loggerhead and Tower Terrace Roads

The City of Hiawatha has been experiencing heavy traffic weighing over ten (10) tons travelling on Loggerhead Road and Tower Terrace Road west of North Center Point Road. In order to prevent premature deterioration of seal coated roads that are not made to withstand heavy traffic, the City of Hiawatha has determined the need to place a temporary embargo on Loggerhead Road (the portion of road located in the City of Hiawatha and Tower Terrace Road. The temporary embargo has been placed for a 90 day period effective April 1, 2014 and remaining effective through June 29, 2014. Any party who violates the provisions of this embargo shall, upon conviction or a plea of guilty, be subject to a fine determined by dividing the difference between the actual weight and the maximum weight established by the resolution by one hundred, and multiplying the quotient by two dollars as per Iowa Code Chapter 321.471. Loggerhead Road, Todd Hills Road and Hunt Road are scheduled to be re-seal coated after July 1, 2014. Seal coating is best applied in July or August when the ground and air temperatures have thoroughly warmed. The City is working with Linn County on this project as a 28E Agreement. Until then, we will have Linn County crews come in and do some preliminary grade work in the rougher sections of these roads. This will take place early this spring. They will scarify the road, add more rock, roll it and provide dust control.

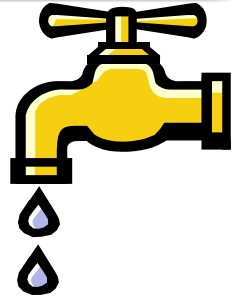

Hiawatha Water Department Flushing Hydrants

If the residents of Hiawatha notice water running into the street, you may think that the Department is ignoring its own philosophy on conserving water. The process of periodically "flushing" fire hydrants, however, is an important preventive maintenance activity. Flushing the water system on a routine basis removes sediment from lines and keeps the entire distribution system refreshed. Hiawatha Water Department maintains over 40 miles of domestic water lines throughout the City.

As a result of the flushing procedure, residents may experience temporary discoloration of their water. This discoloration consists primarily of harmless silt and deposits and doesn't affect the safety of the water. The water is still drinkable. If you experience discoloration, clear the pipes in your own home by running all water faucets for a minute or two. We also advise to postpone doing your laundry until all internal pipes have been cleared.

Storm Water & Mowing Instructions from Community Dev. Dept.

Spring is almost here. The spring showers will be a welcome change from all of this snow and ice. When it rains, the storm waters end up back in our water sources. The storm drains lead to lakes, streams, and rivers. Storm water transports pollutants into our drinking and recreational bodies of water. So please help protect our water quality by following a few simple rules.

- Grass and weeds should be kept at 8" or less. The recommended grass length is 3". When your lawn is 3" tall, it allows water more time to absorb into the soil versus running into the street or onto the sidewalk and towards the storm drains.
- Grass clippings should never go into the street. This clogs storm drains and then affects the quality of our water.
- Direct downspouts away from paved surfaces. All drainage needs to be dispersed on your own property. This helps to prevent pollutants such as motor oil or detergent from entering our water sources.
