


Hiavvatha's Newest Annexation

Once in a while an opportunity comes up to report great news that has been in the making for many months.

Hiawatha is once again growing. The absolute voluntary annexation of approximately 350 acres was completed September 18, 2009. The City now has land to expand in several different zoning classifications after almost being landlocked for several years. The City will probably see new residential development leading the pace in this newly annexed area.

Our new growth area is north of Tower Terrace Road, West of I-380 and along Loggerhead Road, with potential for residential housing and commercial development. The City will begin water and sewer system design with installation to be completed by next year.

The City will additionally provide public safety services immediately.

Hiavvatha Water Department News

The City of Hiawatha pumps water from the Silurian Bedrock Aquifer which is largely a limestone formation with some iron deposits throughout.

When the water moves through these areas, it picks up the soluble iron. When the water is pumped out of the ground and is exposed to the air, iron becomes insoluble and comes out of the water, causing red stains on your laundry. Red staining can also show up in other ares of your home, where water may sit for long periods of time, such as toilets.

Faced with this problem in 2001 and 2002, we constructed the Iron Plant, which consists of two (2) iron removal filters. This plant would have cost over \$500,000.00 if it had been contracted out.



The Water Department built the plant in-house for just over \$200,000.00 by using materials that were a little unusual, such as the three large black tanks, shown in the pictures. These tanks are 12,000 gallon plastic pickle

tanks, made into slow sand filters. We can pump between 500 - 600 gallons of water per minute through two tanks and then the third tank is used for backwashing, which is cleaning of the filters.

In the new addition to the Iron Plant, we included a mural. The mural features a sunrise with a waterfall bursting through the wall. This represents nature at her best and reminds us of a precious natural resource. A lot of people take water for granted. In some places of the world, clean water is unheard of. The mural is also to remind us, Water Department, of our responsibility to provide the people of Hiawatha with clean and safe water.

The Dangers of Feeding Wildlife - Police Department



When the weather turns cold, often people will feed the wildlife, but feeding wildlife does not always have the intended results. Wildlife becomes dependant on people for food and they stop looking for natural food sources. These handouts often have little nutritional value to animals. Feeding deer, for example, can lure them away from protected areas and entice them to move further than they otherwise would, several times a day, often for only a small amount of food or perhaps none at all. Most times feeding sites are in open areas where deer are exposed to cold winds.

In winters past, the deer seemed to congregate in larger than normal numbers in some residential areas. Some of these areas are too small to support them. Gathering large numbers of deer into small areas creates a serious risk for spread-

ing terminal diseases. We have deer in Hiawatha throughout the year, but supplemental feeding congregates deer in unnatural densities. We received photos and reports from homeowners showing seeming significant numbers of deer in one area of town. The spread of disease within and among species is encouraged by repeated and prolonged contact at feeding sites. Deer will over-eat the vegetation in the area including shrubs and gardens.

Raccoons and other small animals will also move into the area for food handouts. Raccoons, like the deer, will be less likely to leave the area when the food supply runs out. They will scavenge trash cans and other places they might find food. Dog food seems to be something raccoons like. We have responded to calls of raccoons, and other small animals, in engine compartments of vehicles and attached garages.

Living in town and experiencing the benefit of seeing wildlife is very appealing to most. Please enjoy the wildlife in your backyard from a distance and do not disrupt their natural feeding.
