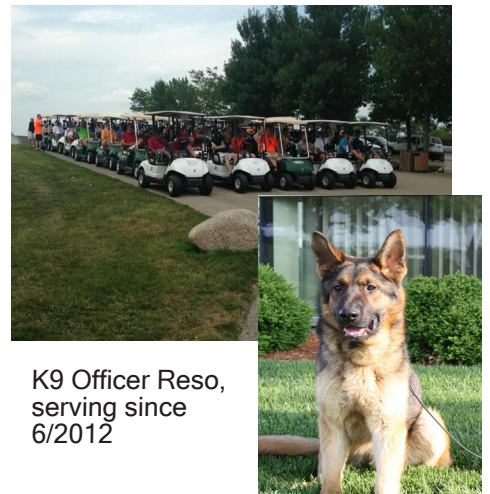
Hiawatha Police Department Second Annual Golf Outing

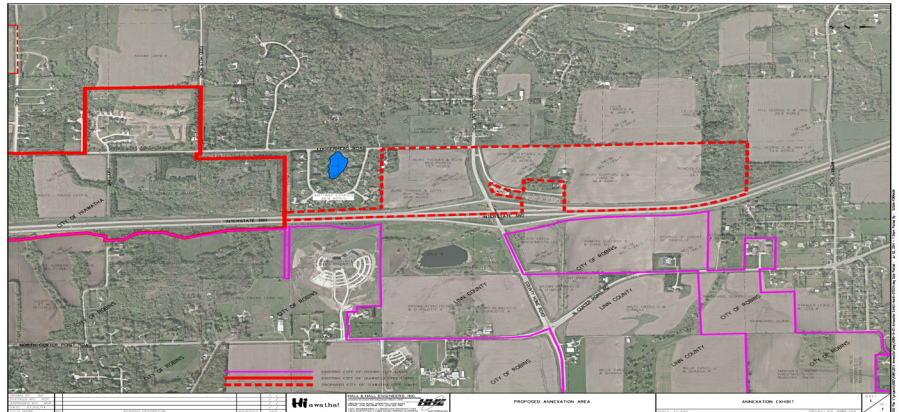

Hiawatha Expands with New Annexation

Upon receiving applications for voluntary annexation, the City Council held a public hearing on August 20, 2014, at its regular meeting. The purpose of the public hearing was to consider the voluntary annexation petitions submitted by Cliff A. Bowers, Diane M. Bowers, Thomas A. Burd, Trustee of Thomas A. Burd Revocable Trust U/D/O August 21, 1997 and Edith Burd, Trustee of the Edith M. Burd Revocable Trust U/D/O August 1997 for property located west of Interstate 380 and north and south of County Home Road with land totaling 122.8 acres. Council approved both applications and entered into annexation agreements with both property owners. Within the agreements, the City of Hiawatha has agreed to extend sanitary sewer and water main into the area to provide service to each of the property owners. The proposed area will assure the City of Hiawatha has available territory for future growth and development.

The City of Hiawatha respectfully requested the City Development Board to consider the annexation proposal at its next available business meeting. The City Development Board will then provide notice of its meeting to consider the filing of the annexation proposal. At this meeting, the Board hears input on whether the proposal is complete and properly filed. If the application is accepted, a date for the public hearing is set. The City Development Board will hold their public hearing for the County and property owners. After hearing all evidence, the Board decides whether to approve or deny the annexation. Upon their approval, the Board notifies the parties and 30 days following notification, the Board files and records documents to complete the annexation, if no appeal is filed the area officially becomes a part of the City by Christmas time.

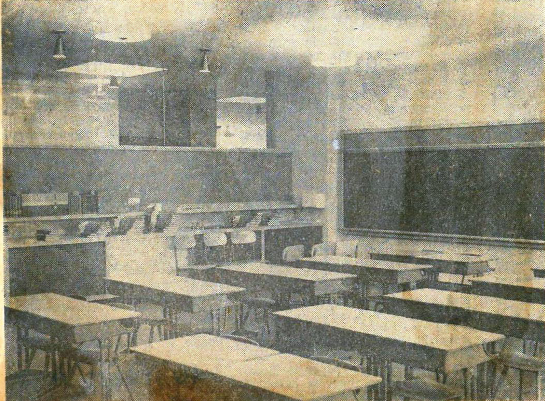
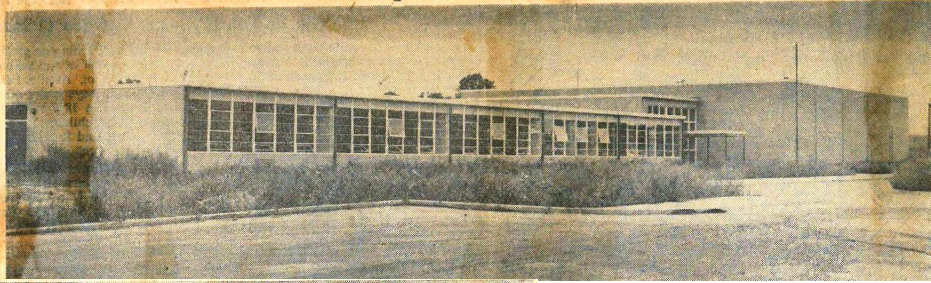

Summer Reading at HPL Inspires Readers of all Ages

Who says reading doesn't pay? The nearly 2,000 readers who were rewarded for their tremendous efforts during June and July at Hiawatha Public Library would beg to differ. Summer reading programs offered incentives to newborns, kids, teens, and adults. In addition, participants were eligible for fabulous grand prizes and unforgettable opportunities.

More than 100 babies and their care givers enrolled in *Little Scientist*, an early literacy program whose prizes included a sippy cup and a board book. Care givers were also rewarded with spa trips and restaurant gift cards. Kids aged 3 through fifth grade earned food coupons; passes to the Blank Park Zoo, Iowa Children's Museum, and Westdale Bowling Alley; toys; and a book for joining *Fizz Boom Read!* One of the 1,120 readers from Hiawatha Public Library was also a grand prize winner of a shiny new bicycle. In addition, eleven participants in the program were randomly selected to win Opportunity Prizes which included riding the fire truck with Fire Chief Mike Nesslage; riding in a patrol car with Police Chief Dennis Marks; decorating the Youth Services bulletin board; or planning Crafts with Ms. Tracy this fall. Teen readers took to the theme *Spark a Reaction* to the tune of 346 participants. As sixth through twelfth graders spent time with books, they earned

food coupons; post-it notes; book bags; pencils; key chains; and a gift card. Teen readers were also vying for grand prizes and this year's most coveted was a gift card to Air FX.

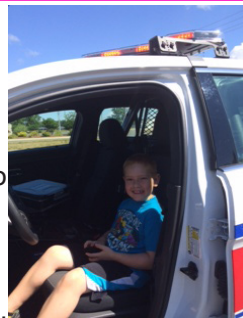

Hiawatha Fire Hosting Events

The Fire Department is hosting several events this fall:

Residential Fire Sprinkler Demo.

On September 27th, the Fire Department will conduct a live fire demonstration illustrating the value of both smoke detectors and residential fire sprinklers. Two "Pods" will be set up with normal household furniture. One with only a smoke detector, and one with both smoke detectors and fire sprinklers. This will demonstrate the speed at which a fire grows, and the value of both safety products. The demonstration will happen in the parking lot of Lowe's on Blairs Ferry Road, starting at 10:30 a.m.

Battery Up Smoke Detector Battery Replacement.

On October 11th, the Fire Department will conduct a community wide push to assist those who are normally unable to, replace batteries or smoke detectors. A working smoke detector provides the advanced notice you need to escape a fire, yet a substantial number of smoke detectors will not operate in a fire as they are either too old, or are missing batteries. To have the fire department stop by your house, call the Grant Wood Chapter of the American Red Cross at 319-393-3500. This is open to owner occupied homes only. In rental units, the responsibility for maintaining the smoke detector rests with the landlord.

Hiawatha Community Development Department Streamlining Processes

The City of Hiawatha is examining our permit process and application requirements in an effort to simplify the process and effectively obtain the necessary information for regulatory purposes. The main focus is to develop processes that continue to assure public safety, protect the environment, and provide for the valued aesthetics of the community of Hiawatha while at the same time being simple and expeditious. The City has modified one permit process and is taking action to align permit requirements, insurance submittals and licensure requirements with the Code of Iowa.

As you may know, the City of Hiawatha has a very extensive exterior lighting ordinance. It is intended to preserve the night sky and to conserve energy. The ordinance indicated the Planning and Zoning Commission (P & Z) was to review all exterior lighting plans after getting a recommendation from the Community Development Department and the City Engineering Department. It was determined by the Board, extensive staff reviews were sufficient assurance of compliance so review by P & Z is no longer a requirement. This allows contractors to commence with their exterior lighting work without having to wait for a monthly meeting and subsequent approval by P & Z.

Contractor registration and licensure are relatively new requirements in the Code of Iowa. The State Codes now contain contractor registration rules and licensure rules for various skills in the construction industry. These new rules eliminate the need for the local jurisdiction to license construction contractors or to require special insurance for working within the community. Not having to require this information locally allows the City to verify and approve applications more efficiently.

Further, the Code of Iowa allows home owners to do work within their existing home without licensure. This includes electrical, plumbing, mechanical, and building projects which are undertaken within the residence that is occupied and owned by the applicant. With anticipated proposed changes to our contractor licensure ordinances, the City of Hiawatha will issue permits for work on existing homes to qualifying owners without licensure or insurance requirements. This will serve to make it easier

for home owners to obtain permits for working on their own homes.

Note: State contractor registration and licensure programs also make it easier for owners to verify contractor credibility within Iowa. The licensure rules include training and insurance requirements statewide for plumbers, electricians, and mechanical contractors. We strongly encourage owners to verify the state credentials of each contractor they may hire at the web sites below. The verification serves as a safe guard against hiring unqualified and sometimes unscrupulous contractors.

14th Avenue & Eisenhower Road Pavement Project Completed

The City of Hiawatha began the reconstruction of *14th Avenue* and *N. 14th Avenue* between *Rainbow Boulevard*, and *Cress Parkway* and the reconstruction of *Eisenhower Road* between *9th Avenue* and *10th Avenue* in rainy June, 2014. The contractor (*Horsfield Construction, Inc.*) completed the majority by the second week of August, with reseeded completed in late August, 2014, resulting in a new smooth driving surface that will serve the City and residents for decades to come.

The project's primary objective was the removal of the existing hump/dip at the intersection of 14th and Emmons, but soon expanded to include much-needed additional items.

New visible items include the removal and replacement of all existing road pavement on both 14th Ave., and Eisenhower Road, new red concrete crosswalks at road crossings, new seeding, new ADA ramps (to enhance pedestrian safety), new energy-efficient LED street lights, and new driveways for residents. The existing road pavements, dating from the original construction of 14th and Eisenhower, had begun to fail as the steel reinforcement started poking through the crumbling surface.

The red crosswalks aesthetically beautify the *genius loci* or sense of

place that is Hiawatha, giving the City a special and unique character, setting it apart from the other municipalities in the region.

The subsurface or below ground improvements include new road subbase, new stormwater subdrain along both sides of both roads that is tied into the new storm sewer on each road, and repairs to sanitary sewer on both roads, all which, though unseen, do increase the new road's life expectancy.

The City would like to take the time to thank all residents, those directly and indirectly affected and inconvenienced for their much appreciated patience during the construction phase.
