**Application for Use of Inflatable’s**

It is unlawful for any person, group or organization to operate an inflatable in any city park or recreational area without the express written permission of the Parks and Recreation Department.

**Renters must provide a copy of Certificate of Liability insurance of at least \$300,000.00 from the Inflatable Company AND a copy of the renters Home Owners Insurance to the City of Hiawatha Parks and Recreation Department prior to the date of the Hiawatha Park Rental.**

All paperwork is due a week prior to the rental date- Use of Inflatable’s are only allowed in conjunction with a park rental. **Only areas next to the pavilions are allowed for set up.**

**Fees: \$25.00 Non Refundable User Fee (In addition to pavilion rental fees)**

There are some limitations in regards to inflatables in all Hiawatha Parks:

1. One inflatable per day
2. Inflatable’s can be no larger than 15 x 15
3. NOT ALLOWED-Water course inflatable’s, obstacle courses, inflatables with slides and or loose accessories.
4. No trucks, cars or motorized vehicles of any kind are allowed in all Hiawatha Parks
5. All inflatable’s must be tied down, properly set up and taken down by the rental company at the end of your designated rental time.
