

The Hiawatha City Council met in regular session in the Hiawatha Council Chambers on January 4, 2017. Mayor Bill Bennett called the meeting to order at 5:30 p.m. Council members present: Dick Olson, Marty Bruns, Aime Wichtendahl, Bob Rampulla, and Dennis Norton. Olson presented RESOLUTION #17-001 authorizing city staff to proceed with filing an application with the Corridor Metropolitan Planning Organization for \$1,000,000 of FY 2021 Federal Surface Transportation Block Grant (STBG) funding, for the purpose of constructing a new interchange on Interstate 380 at Tower Terrace Road from Edgewood Road to North Center Point Road, and committing to provide local matching funds, seconded by Wichtendahl.
