

CAPITAL IMPROVEMENT PLAN (CIP) FISCAL YEAR 2024-2026



The City of Hiawatha's Capital Improvement Plan (CIP) is a five-year long-range plan identifying the city's infrastructure and improvement needs and priorities. The capital project planning is an ongoing process and is reviewed and updated annually. Once approved the CIP outlines the city's official commitment to funding these projects in the upcoming budget. The first year's projects are defined and a financing plan is put into place within the budget to fund those expenditures. Projects include, but are not limited to, street reconstruction, sanitary sewer improvements, storm water improvements, park upgrades and improvements, fire and ambulance vehicles and equipment, water improvements, engineering and consulting services and facility updates. Funding sources are also identified for the projects and can be from general obligation bonds, Tax increment financing, road use tax, enterprise funds, grants and local option sales tax funds. Pictured is a graph of the current CIP showing fiscal years 2024-2026, project type and estimated costs

as approved by council on December 20, 2023.




Chad Pelley (center) was awarded an appreciation plaque from HEDCO for his term as Chair of the HEDCO Board.

COST AND DEADLINE

Each banner costs \$125 which covers the purchase of the banner and installation for two years. The deadline to submit an application for a banner is March 4, 2024, or until availability runs out.

- The honoree is an active-duty member of the United States Armed Forces
- The honoree is a retired or honorably discharged member of the United States Armed Forces who is living or has lived in Hiawatha, or who once resided in Hiawatha and is now deceased

FIRE DEPARTMENT SOFTWARE UPGRADE

The fire department recently started the implementation of a new reporting software for incident reporting, training records, personnel management and inspection record keeping. The new software is more robust in reporting and data gathering than our previous software which will allow us to be compliant in reporting requirements to the State EMS Bureau. We will be able to take advantage of many technology upgrades, with the new software, such as being able to complete reporting in the field and being able to automatically integrate heart rhythms and vitals from our EKG, heart monitor, directly into the report. This will hopefully allow us to go to a paperless reporting process in the near future.

The ability to gather data will be increased. Having accurate and timely data allows the department to make sound decisions and allows us to evaluate the care provided by our responders which will improve patient care. The new software will improve the billing process for ambulance transports as the new program is the same software our third-party billing service uses. Additionally, the new software allows the fire department to combine several software subscriptions under one program which will be a cost savings and will aid in communication within the department. The fire department is excited for the new abilities of the software and the improved reporting it will bring.

Fire Station No. 2

Fire Station No. 2 continues to make good progress. Over the past month, roofing materials were installed over the administrative office space allowing this area to be watertight; brick veneer on the north and west walls have been completed; mechanical and electrical work has begun; and structural steel for the apparatus bay is being erected. Over the next month, mechanical, electrical and plumbing work will continue with some drywall expected to be started. Work on the pre-engineered apparatus bay will continue as weather allows.

2024 Construction Projects

12th Ave and Boyson Road Intersection Improvements – This project entails the construction of a roundabout. The city has been working in coordination with the lowa Department of Transportation on the connectivity to the new Boyson Road interchange project. The IDOT project consists of two new bridges and a new trail connecting to the trail system on both sides of the interstate. The configuration of the interchange will be very similar to Tower Terrace Road. The city recently hired Eastern Iowa Excavating and Concrete to construct this new roundabout. Prior to the main construction beginning in late March or early April when weather becomes favorable, residents and businesses can expect to see utility relocation work in progress. All construction work is expected to be completed by November 2024. The Boyson Road Interchange project is expected to begin in late fall 2024.

Street Improvements – This project is currently being developed. At this time, 11th Ave from Emmons St to Rainbow Blvd and 1st Ave from Blairs Ferry Rd to Willman St will include the following: New concrete curb and gutter as needed; cracking of the existing pavement; new asphalt overlay; and updates to existing curb ramps to meet ADA requirements. This project may expand if budgets allow.

Hiawatha received 8-12" of heavy snow on the evening of January 8th into January 9th. Winds picked up on the 9th causing reduced visibility and snow drifts. Another round of snowfall started on the night of January 11th lasting through January 12th, accumulating an additional 4-6" of powdery snow. On the 12th, wind gusts of 35 to 45 mph causing whiteout conditions. In addition to blizzard conditions, wind chills dropped the temperatures down to -30s to -40s by January 15th causing life-threatening danger with this winter storm.



Staff samples the wells providing water and the water system to seek out and find unregulated contaminants under the Unregulated Contaminant Monitoring Rule (UCMR) to stay ahead of potential health risks.
