### Hiawatha Parks and Recreation Regular Meeting August 8, 2017

Deb Theis called the meeting to order at 6:36p.m. in the Hiawatha Council Chambers. Present: Dan Wilkes, Deb Theis, Dawn Ewoldt Absent: Dan Gogel and Brandon Lynch Employees: Kelly Willadsen, Parks and Recreation Director, Ambyr Young, Administrative Coordinator. Guests: Dan Hoffman. Motion by Dan Wilkes, second by Dawn Ewoldt to approve the August 8, 2017 agenda as amended. Motion carried. Motion by Dan Wilkes, second by Dawn Ewoldt to approve the minutes of June 13, 2017. Motion carried.

Approval for Kona Ice to attend August 13<sup>th</sup> pavilion rental- On Sunday, August 13<sup>th</sup> Cathy Muller, would like to have Kona Ice come to the Teal Pavilion at Clark Park for her daughter's fourth Birthday party. They will arrive at 11:30am and leave by noon. This will only be for her invited guests at her rental. Kona understands our City policy and we have never had issues with them.

Motion by Dan Wilkes, second by Dawn Ewoldt to approve Kona Ice to attend August 13<sup>th</sup> Teal Pavilion rental. Motion carried.

Approval for HKL solar panel installation- The Hiawatha Kids League is seeking permission to install a green energy producing alternative; solar panels atop the Guthridge Park concession stand. These 2 or 3 solar panels  $(3.5' \times 5.5')$  would offset the energy consumption and would produce the most solar power if mounted onto the roof section facing the south; this has 200 gross square feet of area or 75 square feet of viable set back square feet. The solar panels need to be in proximity to the concession stand meter.

The solar system would produce approximately 1160 watts or 1.16 KW (\$200) per year and the HKL energy consumption averages 5.5 KWH each season or (\$500). The offset would be captured with a bi-directional meter provided by Alliant Energy; the meter would spin in the opposite (favorable) direction when energy was being produced by the solar panels.

Moxie Solar from North Liberty, Iowa would conduct the installation with certified contractors and electricians. Total cost would be under \$4000, HKL intends to pay for the installation and maintenance of the solar system with City guidance. Hiawatha Kids League has earned a Green Communities grant for \$2500 and would pay for the balance of the installation with budgeted funds for special projects. Moxie Solar would initiate a contract with the City of Hiawatha and abide to all the necessary codes and installation requirements for proper mechanical and electrical functionality. Desired installation would be for the fall of 2017. Before install the City will need to remove the maple tree in front of the concession stand for safety purposes so that kids cannot climb on the roof moving forward. There will be a tree replanted after construction.

The Solar Panel would demonstrate to the youth and families of the league the benefits of green energy alternatives and how solar energy is converted into useful applications in the concession stand. The solar

panels have a life span of over 20 years and would help HKL defray the cost and use of traditional energy for year to come.

Kelly, Kim Downs, Patrick Parsley (Community Development) and Mark Parmenter (City Attorney) met with Chris Richards who is the head of project to discuss moving forward and making sure all permits and necessary guidelines are met by the Park and Rec and Community Development departments. Mark Parmenter included a draft that explains the partnership and what is expected of Hiawatha Kids League moving forward. Hiawatha Kids League will be responsible for maintaining the panels once they are placed on the facility. I am asking for a recommendation to council to move forward with the construction of this project. Hiawatha Kids League has done great things for our community. With your approval, this will go to City Council at the August 16<sup>th</sup> meeting.

Motion made by Dawn Ewoldt, second by Dan Wilkes to recommend to council to approve the installation of solar panel at Guthridge Park. Motion carried.

End of year report- Included all the accomplishments of the fiscal year 2017.

  adjustments for 2018 to make sure all our expenses are covered. Thank you to our Friends
  Foundation for assisting with program supplies and field trip expenses.
- Fun Fest 2017: August 25-26<sup>th</sup>, 2017. We need volunteers! Please gather your family and friends and donate a bit of our time to our community celebration! Koozies are going to be handed out at upcoming events to help market the occasion! We need help at the Kids Tractor Pull, Euro Bungee and kids activities. Let us know where you would like to help!
- **Tennis:** Session two has wrapped up and the final session of the year is in full swing. Two tots are learning the basics on Wednesdays from 4 to 4:45pm.
- Blastball: Blastball was extended an extra week after the lowa weather through the teams a bone
  crushing curve ball and cancelled several of their scrimmages. No pinch hitters here, these three
  to five-year old's were at bat and ready to hit their very first dingers. Blastball is brought to the
  community by World Class Industries.

- Movies under the Moon: July 21<sup>st</sup> movie in the park was cancelled due to the crazy summer weather. We were unable to reschedule due to the equipment rental but will be ready for our next movie showing August 25<sup>th</sup>!

  many changes to the Sunday market this year and will be waiting to see what location is best for
  the weekday market for 2018. Some suggestions were made for the current market such as no
  parking on one side of 10<sup>th</sup> Ave and to move the Handicap spots to the right of where they are
  currently

**Community Center yearly non-profit rate increase for 2018:** Nonprofit yearly rentals have not had an increase in over 5 years. Right now, they pay \$300 for a 12-month calendar year, which allows them to rent once a month.

This brings the price to \$25.00 per rental. We would like to increase the fee by \$120 a year bringing the yearly rate to \$420 and \$35 per rental. This will keep us very comparable to other Cities our size yet help us keep up with the maintenance costs as the center continues to get older. I would like your approval to increase the rates and make this effective January 1, 2018.

**Community Center A/V prices for non-profit renters:** The City has never had an A/V fee adjustment for nonprofit rentals. We recently had a request from a non-profit group asking if we have a discount for the system during their calendar year meetings. We don't have many groups that ask for it but decided to put a plan in place in case we get more non-profits asking. We usually charge a rate of \$40 for the equipment (system, microphones, projectors, connection cords), we would like to give them a 50% off discount making the rental fee \$20.00. This would go into effect starting January 1, 2018 when the rest of the contracts are updated.

Community Center Price Increase for 2018: With the Community Center continuing to get rented every weekend we would like to increase the rental rate for 2018. Since we added the non-resident rate we have not seen a decrease in rentals but an increase from the surrounding cities. Over 2016-2017 we had 377 rentals total, 86 out of Hiawatha, 210 from Cedar Rapids, 27 out of Marion and 54 from surrounding cities. With that said we would like to increase the non-resident and resident fee \$25.00 to make the costs for the facility as stated below:

**Resident:** \$175 per rental/\$250 all day **Non-**Resident: \$200 per rental/\$275 all day

We don't believe this will affect our rentals, it will help us stay average in price compared to other cities our size and the amenities we offer. This would go into effect January 1, 2018.

### Hiawatha Kids League Request for Guthridge Park Baseball Diamonds 2018:

Please see the request from HKL chairman Scott Fisher for Guthridge Park ball diamonds. All of these dates requested work based off of our City schedule.

Disc Golf Putting Project: A Clark Park disc golf user would like to add a basket to the disc golf course. This basket would be near the pavilion and trail in between holes 17 & 18 at the top of the hill. This basket would be used as a practice area for putting and can be used to play "around the world" or "pig". Purposed there would be 18 markers around the basket to throw from but after meeting with a few of the disc golf leaders, they thought 9 markers would be efficient enough since there are the same lengths on some of the sides. Each of the markers would be cemented in with numbers associated with each one. These markers would be level with the ground for mowing purposes. The project would be funded by the disc golf users (\$500.00-700.00) as well as installed with the approval from the board and of Parks staff. There is only one other putting area in Iowa that is located in Ames. These are largely used in Colorado and California for avid disc golf users. (diagrams attached)

### Parks:

Parks will be closing the last week of October. Guthridge Park will stay open until the last Farmers Market.
 Port O Johns will be delivered the first week in November for Guthridge and Clark Park.

- We are doing the last mowing, aerating and fertilizing on city grounds.
- Ted Olson, park maintenance, stripped and waxed the Community Center floor October 3-4th. We try to get this done at least two times a year to keep the facility in good shape. This process takes two full days to complete.
- As of right now the dog park partnership with Dave Wright and Linn County is on hold. Kainz Park and the detention basin next to the Cedar Valley Trail were granted to the City in 1992 by Linn County for \$1.00. Restrictions on the land require the properties to remain used for public purpose. The original plan was for the City to sell the land (interest by Dave Wright) and purchase the land area from Dave Wright to construct a dog park which he would help develop donating \$90,000. With Linn County not wanting us to sell the land, and because it needs to stay a public purpose we are on hold with the project. Dave Wright will not complete this project if he can't purchase the Kainz Park and detention basin.
