### Spring Means Door-to-Door Solicitation

Spring is here and warmer weather brings solicitors to our community. A solicitor is any person engaged in peddling, soliciting or in the business as a transient merchant. Each person must complete an application in writing and file it with the City Clerk's Office ten days prior to the first day of any sale, offer for sale or solicitation is made.

The City will conduct a background check on each and every person applying for a license and application, additionally, all documents will be submitted to the Police Department for review and approval. Once the license is approved by the City Clerk and the Police Department, the peddler, solicitor or transient merchant is then able to start knocking on your door. Every person is required to carry their license and a Hiawatha Solicitor I.D. badge.

Solicitors may find unique ways to gain access to your home, such as offering a free grocery drawing or coupons for free service, giving solicitors the ability to call upon you at your home for the purpose of an in-home presentation or demonstration.

As a citizen living in Hiawatha, you have the ability to turn the solicitor away. However, if you decide to continue a conversation, you should ask the individual to see their identification if it is not in plain sight. Their Solicitor I.D. badge is evidence of compliance with all requirements of the City. The badge will display a photograph and the length of time the license is issued. If the individual is unable to display their badge, it is important you call the Police Department immediately at 319-393-1212.

All peddlers, solicitors, and transient merchants license time restrictions are 8:00 a.m. to 8:00 p.m., seven days a week.

### Finance Department Reports on Budget Levy Rate

The City of Hiawatha elected officials have made some hard decisions weighing the needs and benefits of projects and services against their associated costs. The tax rate will change from last year's rate of \$15.53 to \$15.15 per \$1,000 of assessed taxable valuation for the Fiscal Year 2012 - 2013. The tax levy rate went down \$.38 per thousand or 2.4% from last year. An owner of a home valued at \$100,000 will pay \$769.27 in taxes to the City of Hiawatha in the fiscal year beginning July 1, 2012.

The quality businesses that have located in Hiawatha continue to be a great asset to our community. In effect, residential property owners pay a lower percentage of total taxes as business development continues to occur. The overall result is a balanced tax base for the community.

Hiawatha has been able to keep our tax rates reasonably low and stable due to the diligent efforts of your Mayor and Council Members on economic development and fiscal matters. With their continued efforts, Hiawatha will continue to provide taxpayers the best cost-of-living value in the area.

# Cedar Valley Nature Trail



Grab your bikes, helmets, and water bottles and come enjoy the 52 mile Cedar Valley Nature Trail that connects Evansdale with Hiawatha, and runs through several small towns in between. The trail follows along an abandoned railroad right-of-way, which at one time was the old Waterloo, Cedar Falls, and Northern, an interurban railroad system established in the early 1900's. The trail is surfaced with asphalt from Evansdale to McFarlane Park, which is just 2 1/2 miles south of La Porte City. From the Park to Hiawatha, the trail is surfaced with compacted limestone. A campground is located in McFarlane Park, which is right next to the trail.



The Cedar Valley Nature Trail runs through wetlands, forested land, and farmland - an excellent place to spot wildlife, including deer, badgers, wild turkeys and song birds. You'll spot wildflowers, historical landmarks, archeological sites and two restored depots.

### History Commission on Kauffman Hardware

In 1968, George and Mary Kauffman opened a much needed hardware store at 106 N Center Point Rd. The building still exists today, but has a gable roof instead of a flat roof. The second floor has three apartments. The property included two rental houses, one on either side of the driveway off Center Point Road.

The hardware store was a "life saver" for many people just building their first home in the 60's and 70's. If a problem or an emergency with home building or repairs occurred after store hours, George or his daughter, Rita, would open the store and help the person find the necessary tools or hardware they needed.

Around 1978-79 business fell off when Sutherland Lumber built on Blairs Ferry Road where Welters is now located. The Kauffman Hardware building and its contents were sold at auction. In 1960, the Kauffman's lived on an acreage in a big farm house at 11 N Center Point Rd., where Wrightway Trailers is located now. The original address was R.R.#1 Marion, Iowa until Hiawatha

annexed land north of town. The Kauffman's had nine children; one child passed away in 1968. Most of them helped at the store at one time or another. They later moved to an acreage on County Home Rd., and lived there for several years, and recently moved to Cedar Rapids.

Still to this day, George would help a person in need with a smile on his face and a kind word.

# L.E.D. Streetlights

After completing reconstruction of North Center Point Road, City Officials in Hiawatha, have initiated plans for Hiawatha's first Light Emitting Diode streetlight project. The overall scope of the reconstruction effort involves three roadway lanes, sidewalks, trails and streetlighting spanning approximately one mile. Plans include the purchase and installation of about twenty-five cobrahead LED streetlights.

"Initially we considered solar streetlights but eventually determined that it was not the most effective choice for our City. This is the first time our City will install LED streetlights, and we are anticipating significant energy cost savings," said Tom Theis, Mayor of Hiawatha. The project is partially funded by a \$66,400 award from the Iowa Office of Energy Independence Grant. The total project cost is estimated at \$282,000, according to Ken DeKeyser of Hall and Hall Engineering.



"We are not specifying a particular manufacturer or fixture, but we will identify performance based specifica-tions and have a Buy American requirement due to the federal funding," said DeKeyser. Project plans and specifications have been issued with a bid scheduled for April 11, 2012.

### Local Option Sales & Service Update

Just over 14,000 Linn County Residents cast their vote in the March 6, 2012 Local Option Sales & Service Tax referendum on the proposed 10 year extension to the 1% local option sales tax. Local option tax vote results by city

If the tax vote had been yes, the City's intentions were to provide up to 10% tax relief and provide for infrastructure improvements and other lawful purposes, etc.

Thank You for voting, whether you voted "yes" or "no", we appreciate the time you invested in gathering information to make an informed decision as you step up to the voting booth.

You may be asking yourself, "Can a Local Option Sales & Service Tax (L.O.S.S.T.) Election be called for again?"

Yes. If one or more jurisdictions in a county do not currently have the tax imposed or will not have the tax imposed at a point in the future, a Local Option Sales & Services Tax election can be called. The Code of Iowa does not mandate certain wait-time between elections. Therefore, another election can be called immediately for any eligible special election date. As with this past election, the City of Cedar Rapids, with its population of over 50% of the county, is the only jurisdiction that can call for the election. A peti-

# Happy Spring and Happy Mowing!

Time to dust off your lawn mowers, tune-it up and get ready for the mowing season. As you mow, please remember to direct grass clippings back towards your lawn and away from streets, driveways and sidewalks. Growing grass benefits from all the great nutrients found in lawn clippings. Clippings left on impervious surfaces are washed down the storm drain and into the closest creek or stream. Once there, nature works to decompose the grass clippings and while doing so, depletes the oxygen in the water, which fish and plants need to survive. Keeping grass clippings out of the street is a simple step we can all do to keep lowa's waters clean and healthy.

It's also important to note that according to Hiawatha Code of Ordinances Section 50.02.10, "...said lot mowed so that grass and weeds are less than eight (8) inches in height."
