## 2015 - 2016 Fiscal Year Budget - Finance Department

July 1, 2015 marks the beginning of a new fiscal year for the City of Hiawatha. The city's finances are divided into 6 categories/funds, which include, General Fund, Special Revenue Fund, Tax-Increment Financing (TIF) Fund, Debt Service Fund, Capital Project Fund and Enterprise Fund.

The General Fund is the chief operating fund of the city. It supports operations including Police, Fire Ambulance, Library, Park and Recreation, Building, Mayor and Council, Clerk and Finance, City hall, Legal fees and Election expenses.

The Special Revenues Fund contains the proceeds from a specific source which are required by law to be accounted for separately and used for specific purpose. Included in the Special Revenue Fund are TIF revenues, Road Use Tax, Local Option Sales Tax and Employee benefits.

The TIF Fund is a special revenue fund that helps the city in achieving a variety of economic development goals, including job creation, growth in property values and protection of the local tax base. TIF can also be used to finance public improvements (such as streets, sewers, water, sidewalks and other infrastructure).

The Debt Service Fund is dedicated for the payment of principal and interest on the city's long term debt. This is a special levy that the council approved in the budget to pay for our debt payments in FY16.

Capital Projects Fund is used to account for the resources used in the acquisition and construction of large capital projects including but not limited to street construction, water and sewer main extensions or repairs, equipment, building, land acquisitions and storm sewer installations or repairs.

The Enterprise Fund consists of the operations and maintenance of the city's utilities including water, sewer and storm sewer.


Illustrated in the chart below are the budget expenses by fund for the upcoming budget year of July 1, 2015 to June 30, 2016. As you can see the Capital Project Fund is the

largest portion of the city's budget, 25% of the total budgeted expenses equaling \$5,058,900. General Fund is the next largest, at 21% of total or \$4,277,667. Special Revenue is next at 16% or \$3,279,770. Debt Service is at 16% or \$3,174,514, this includes the payments made for all of the city's debt. TIF expenses include payments of principal and interest on the city's debt and the Development Agreements that are in place to aid in economic development. The total operating budget for the city in the upcoming fiscal year is \$20,097,871.

At the March 4, 2015 regular council meeting, the City of Hiawatha City Council adopted the budget for the upcoming Fiscal Year 2016 that will begin July 1. Discussions began last fall with department managers and council members by setting priorities and goals for the coming year.

The City of Hiawatha elected officials have weighed the needs and benefits of projects and services against their associated costs. Some of the projects included in the FY16 budget include Water, Sewer and Storm Sewer improvements, updates in the Park and Recreation department, Library, Fire and Ambulance: service and the Police department.

The tax rate will change from last year's rate of \$15.20 to \$15.40 per \$1,000 of assessed taxable valuation for the Fiscal year 2015-2016. The city's tax levy is a very important part of the residential propertytax equation. A property owners' tax bill is determined when Linn County Assessor values a property and the state sets a "rollback," or what percentage of the value of property is subject to tax. The property value is then multiplied by the levies of the other jurisdictions with taxing authorities, such as the State of Iowa, Linn County, local school districts and Community Colleges.

#### Sign Grant

In February, the City applied for and received an in kind grant for sign replacement in the City.

These signs are regulatory signs consisting mainly of stop, yield and speed limit. The grant will supply the City with \$3,476 worth of signs, posts and hardware.



The signs we are replacing have to be maintained to a minimum reflectivity according to the Manual for Uniform Traffic Control Devices.

As part of our Sign Maintenance Policy, over the next 5 years we will be replacing various regulatory signs throughout the City. The signs we just received will the first phase of our maintenance plan.



## **Backflow Prevention Devices**

REMINDER TO HIAWATHA RESIDENTS: If you have a Backflow Prevention Device on your water line, please remember that this needs to be tested yearly (preferably in the spring) by a registered technician per City Ordinance.

Inspection forms may be picked up at City Hall or your registered technician should have similar forms. In addition to this, any new building in Hiawatha requiring a Backflow Prevention Device must register the device through the City. Forms can be found at City Hall from either the Community Development Department or Water Department. If you have any questions, please call the Water Department at 319-393-5556 opt. #4.

## The Importance of Flushing Water Lines

If the Residents of Hiawatha notice the Water crew working at fire hydrants and see water running into the street, you may think that the Department is ignoring its own philosphy on conserving water. The process of periodically "flushing" fire hydrants, however, is an important preventive maintenance activity. Although it may appear to waste water, this process is part of a routine maintenance program necessary to maintain the integrity of the water system and to continue to deliver the highest quality water possible to our customers.

Flushing the water system on a routine basis removes sediment from lines and keeps the entire distribution system refreshed. Hiawatha Water Department maintains over 40 miles of domestic water lines throughout the City.

As a result of the flushing procedure, residents in the immediate vicinity of the work may experience temporary discoloration of their water. This discoloration consists primarily of harmless silt or deposits and does not affect the safety of the water. The water is still drinkable. If you experience discoloration in your water after crews have been flushing in your neighborhood, clear the pipes in your own home by running all water faucets for a minute or two. We also advise to postpone doing your laundry until all internal pipes have been cleared.

This same philosophy of water line preventive maintenance is one that you should use in your own home. Your home's water heater should be drained and flushed at least once a year to keep it working efficiently and to protect the quality of water inside your home. Also, if you go out of town and there is no water use in your home for a week or more, when you return it's always a good idea to run all your faucets for a minute or so before using the water. This ensures that you don't use any stagnant water that may have developed in your home's pipes while you were away.

Starting Monday, April 20, 2015 through Friday, May 22, 2015, weather permitting, Hiawatha Water Department will be flushing hydrants.

# Adoption of Building Codes

The City of Hiawatha has completed its process for the adoption of the 2015 International Model Building Codes (I-Codes). These codes took effect in Hiawatha on March 14th, 2015. The adoption of the 2015 I-Codes will facilitate uniformity in the Corridor as they have already been adopted in Marion and are scheduled to be adopted in Cedar Rapids this year.

It is important for building codes to be regularly updated. The most current codes recognize the newest construction methods, materials and life safety standards available, create more options and versatility in new and existing construction projects, and facilitate uniformity when adopted regionally. These benefits enhance public safety in the built environment and at the same time make it easier for contractors to work in multiple jurisdictions with minimal code related disruptions.

The process for adopting the I-Codes begins with the development of the codes through the International Codes Council (ICC). The codes are developed by ICC in a process which includes industry and governmental input. The local jurisdictions of Hiawatha, Marion and Cedar Rapids are among ICC's government members and as such participate in the development of these codes. Construction industry stakeholders such as manufacturers, designers, and contractors along with government regulators alike, propose and decide on changes to

the International Codes. The process includes committee hearings, public hearings and membership votes over a three year period. Consequently a new set of codes is published for adoption every three years.

This intense process of code development on a national level allows local code development and new code adoptions to be streamlined. In the past each jurisdiction was responsible for writing and maintaining their codes from start to finish. It was a costly labor intensive and time consuming process for each city. This Hiawatha code adoption included city staff participation in a process initiated by the City of Marion. The committee structures included representation from the Appeals Board of the City of Marion, city staff from Marion, Robins, Cedar Rapids, Linn County and Hiawatha,

along with representatives from the construction industry. After participating in the committee process the Hiawatha Community Development Department developed adoption ordinances for the 2015 Building Code, Fire Code, Residential Code, Mechanical Code, Plumbing Code, Property Maintenance Code, Housing Code and the 2014 National Electrical Code. The guidelines for the ordinances included these objectives:

- Strive to be uniform in the Corridor area
- Limit the cost impact on construction
- Maintain present life safety and sanitation standards
- Adopt the I-Codes with minimal changes as these codes reflect national consensus

The Building Codes adoption process culminated with the Hiawatha City Council public hearing and subsequent passage of the ordinances incorporating the new model codes into the Hiawatha Code of Ordinances on March 4, 2015. The Icodes are now in place for the 2015 building season and can be purchased at www.iccsafe. org. ## City Employees Attend Annual Stand Down Safety Day

On March 11, city employees attended Stand Down Safety Day held at City Hall. Stand Down Safety Day is held annually as a reminder of the importance of safe work practices as well as promoting overall health and wellbeing. Having safety practices in place such as individual departments talking about safety as they see potential risks arise and requiring employees to attend Stand Down Safety Day and quarterly safety training sessions, is important to provide necessary education on performing tasks safely and reducing and avoiding the risk of danger. These types of safety practices also help increase employee awareness of a safe and healthy environment.

During Stand Down Safety Day employees attended training sessions including tips for reducing stress and stretching exercises presented by Jane Thurm from Holistic Pilates of Cedar Rapids. The Hiawatha Fire Department provided training on Bloodborne Pathogens to help protect workers who may come in contact with blood or other potentially infections materials while performing their job duties. Mike Whitmore of OSHA presented information on slips, trips and falls prevention.



The Hiawatha Police Department with the help of Tom Daubs from the Marion Police Department, presented the last training session of the day when they lead employees through ALICE training. This was the first time Hiawatha employees experienced ALICE, which for those of you who aren't familiar with this training, ALICE stands for Alert, Lockdown, Inform, Counter and Evacuate. The city felt it was important to provide ALICE training to employees to prepare them with survival techniques to implement during an active shooter or intruder situation. The ALICE session included classroom presentation followed by four live scenarios using the concepts learned during the training. During the scenarios, Jud Starn, Hiawatha Reserve Officer enacted the part of the bad guy using a simunition gun which fired blanks. Access

to City Hall was blocked while the scenarios were being performed for the safety of both the public and the employees.
