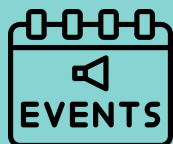

KEEPING OUR WATER CLEAN: SMART SALT USE FOR WINTER SAFETY

When winter comes, many of us reach for salt to melt ice on our driveways and sidewalks. But did you know that using too much salt can harm our local streams, lakes, and ponds? Salt, or chloride, doesn't go away over time. It builds up in our waterways, where it can hurt fish, frogs, and water plants. What's more, salt can damage our roads, bridges, and vehicles. It eats away at concrete and metal, leading to costly repairs. The good news is that we can still stay safe in winter while protecting our environment and infrastructure by using salt smartly.



The best way to deal with snow and ice is to shovel or sweep it away. This old-fashioned method is free and doesn't harm the environment or our infrastructure! If you need something for traction, try sand or even birdseed instead of salt. These won't melt ice, but they'll help prevent slips and falls. If you do need to use salt, remember that a little goes a long way. Think of salt like sprinkles on a cookie – you only need a small amount to get the job done. This not only protects our waterways but also helps preserve our roads and vehicles.



There are also some alternatives to regular road salt that are better for the environment and less damaging to infrastructure. Calcium chloride works well in very cold temperatures and is less harmful to plants and concrete. Some stores sell salt-free deicers that are safe for pets, the environment, and our roads. Whatever you choose, always follow the instructions on the package and use as little as possible. By being smart about how we deal with ice and snow, we can keep our driveways safe, our water clean, and our infrastructure in better shape for years to come.

WINTER IS COMING, STAY INFORMED

The City of Hiawatha has snow removal rules in place to help keep our community safe.

Here is what you need to know before winter weather strikes:

- Make sure sump pumps and downspouts don't drain to sidewalks. The drainage can freeze causing icy buildup and slippery conditions on driveways, sidewalks, and streets.
- Sidewalks must be cleared within 24 hours after a snowfall event ends. Remember to clear the area around fire hydrants as well.
- When removing snow from your property, do not place it in streets, alleys, driveways, or on sidewalks.
- Commercial Properties – Make sure you have a snow removal plan in place this winter season. If there is not enough room to store pushed snow on the property, you must have a plan for snow removal from the site before snow clearing may take place.

Snow Ordinance

Hiawatha's snow ordinance helps ensure safe, effective, and rapid snow removal of our streets. You can help! Do not park in the street when:

- The National Weather Service predicts three (3) or more inches of snow within 24 hours OR three (3) or more inches of snow has fallen and your street has not been cleared.
- Vehicles parked in the street during an active snow ordinance will be issued a \$25 ticket. If vehicles are parked on City streets during overnight snow removal operations, they will be towed. When in doubt, move your vehicle off the street.

Note: The City does not conduct snow removal operations on all city streets for snowfall less than two (2) inches.

Stay Informed

If a snow emergency is declared, local media outlets will be informed. This includes, but is not limited to, KGAN (Channel 2), KCRG (Channel 9), and KWWL (Channel 7). The declaration will also be posted on the City Website: www.hiawatha-iowa.com.

Roughly 1 in 10 Linn County residents experience food insecurity, and approximately 270,000 lowans rely on SNAP benefits month to month. With the disruption to SNAP benefits due to the lengthy federal government shutdown, food pantries across the state are experiencing drastic increases in people seeking aid (including the food pantry here at Hiawatha Public Library).

Details are still in flux at the time of writing this, and there is a lot of uncertainty about what amount of November benefits SNAP recipients will receive, and when they will receive them. The latest information available is that the USDA would be issuing 65% of typical SNAP benefits for November.

However, due to the way this change is being applied to how benefits are calculated, many households will receive far less than 65% of their regular benefits. Additionally, it may take several weeks or months for these partial November benefits to be recalculated and issued to food insecure lowans.

Direct Assistance

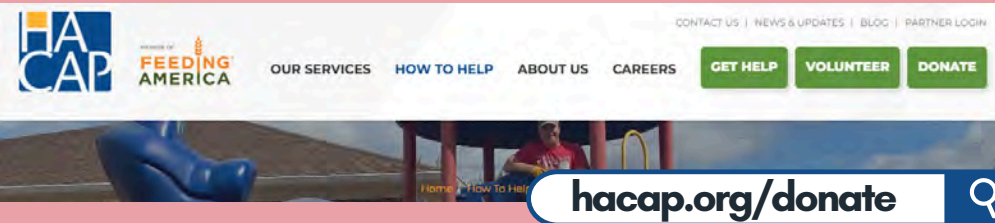
- If you know a family that is food insecure, consider assisting them directly by helping them pay for their groceries. This will reduce the need for that family to rely on already overwhelmed food pantries.

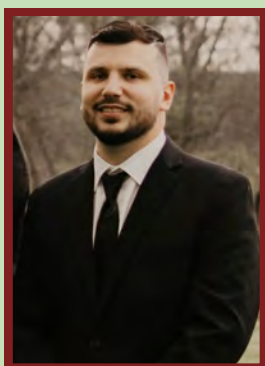

FINES FOR IOWA'S HANDS-FREE DRIVING LAW BEGIN JANUARY 1, 2026

The Hiawatha Police Department reminds drivers that starting January 1, 2026, fines will begin for violations of Iowa's new hands-free driving law. The law, which took effect July 1, 2025, makes it illegal for drivers to hold or manually use a phone or electronic device while operating a vehicle. For the past six months, officers across Iowa have issued warnings to help drivers adjust. Beginning in January, violators can be fined \$100 for a first offense. Fines increase significantly if distracted driving contributes to a crash causing injury or death. The goal of the law is to reduce preventable crashes and keep Iowa's roads safe. Drivers may no longer text, scroll, or hold their phones while driving. Devices can only be used in hands-free or voice-activated mode, such as through Bluetooth or a mounted phone holder. There are limited exceptions. Emergency responders may use communication devices while performing official duties. The law also allows the use of built-in vehicle systems or mounted devices that operate hands-free. Chief Kamm reminds drivers, "This law isn't about writing tickets — it's about preventing tragedies. Keeping your hands on the wheel and eyes on the road saves lives." He added that during his 21-year career, he has seen far too many preventable accidents caused by drivers distracted by their phones. "The law is just one piece of the puzzle," Kamm said. "Real safety depends on every driver's willingness to make the responsible choice — to put the phone down and focus on driving."



The Hiawatha Police Department urges all motorists to take action now:

- Use a hands-free mount or built-in Bluetooth connection.
- Set your GPS or music before you start driving.
- Turn on 'Do Not Disturb While Driving' mode.
- Pull over safely if you need to use your phone.

INDIAN CREEK WATERSHED SIGNS HIGHLIGHT LOCAL WATERWAYS AND COMMUNITY PARTNERSHIPS

The Indian Creek Watershed Management Authority (ICWMA) is working to connect residents with their local waterways through the installation of new watershed signs. ICWMA within Linn County was one of the first WMAs in Iowa (est. 2012) and is the collaboration of six member organizations, including Cedar Rapids, Hiawatha, Marion, Robins, Linn County, and the Linn County Soil and Water District. ICWMA received an Iowa Department of Natural Resources grant to expand its creek sign outreach effort, which has resulted in 127 signs being installed at 39 locations across the Indian Creek watershed. The tributaries of Indian Creek include Dry Creek, Wanatee Creek, Berrys Run, East Indian Creek, and Willowood Creek. These signs, now visible in Alburnett, Hiawatha, Cedar Rapids, Marion, Robins, Linn County, and Linn County Conservation parks, help residents recognize when they are entering the Indian Creek Watershed and understand their role in protecting water quality. The project was made possible through strong partnerships, with public works and secondary road crews from each jurisdiction committing in-kind labor to install the signs. As a result of this grant Hiawatha staff has installed 3 watershed signs in Hiawatha. Two are on the Boyson Rd bridge over Dry Creek and one is on Tower Terrace Rd as you enter the Dry Creek watershed.

How You Can Protect Local Waterways

A watershed is the area that drains to a common waterway, such as a stream, lake, estuary, wetland, aquifer, or ocean. The land that drains to the waterway affects the water quality. Since we all live in a watershed, it is a community effort to protect it. Here are the things you can do to help protect the water quality in your community:

- Keep waste out of drainage areas
- Pick up litter
- Minimize use of pesticides
- Plant native species
- Properly dispose of hazardous waste

In addition to the years of service awards the department also recognized several CPR Save awards. The CPR save award is presented to members that were a part of a call



where CPR was performed and the patient was successfully discharged from the hospital. The following members received a CPR Save award: Pacer Langguth, Chloe Mogensen, Branden Chiles, Miranda Gettle, Olivia Zwierzko, Elijah Mallicoat, Brett Herman, Brad Wiggins, Chief Matt Powers, Deputy Chief of EMS Nick Jellison, Collin Wheat, Kyle Griffin, Kyle Thoreson and Alec Battien. Chris Hicks and Brad Ransford were both given this year's Fire Chief Award. Chris Hicks was recognized for his assistance completing several vehicle related projects that saved the city thousands of dollars. Brad Ransford was recognized for his continued dedication to the department and taking on additional responsibilities this past year by covering an open crew officer position while continuing to cover his normal roles as the Training Captain. Congrats to all the members that were recognized and thank you to all of the members for their dedication and service to Hiawatha, making it a safe place to live, work, and play by caring for the community.

2024 BUILDING CODES ADOPTED

The City of Hiawatha has completed the process of adoption of the newest model building codes. Keeping current with modern codes allows us to take advantage of the most current building technologies for methods and materials, gives us an opportunity to evaluate our standards for promoting safety in our built environment and facilitates uniformity of codes with the surrounding jurisdictions.

On the local level the adoption is simplified since Hiawatha has already participated in the updates through the International Code Council (ICC); a non-profit organization overseeing uniform building code development. Our Building and Fire Appeals Board reviewed the new codes and significant changes. The Board also considered input from the surrounding jurisdictions and the county for maintaining uniformity. Their review provided a recommendation to Council for final adoption.

The significant changes were very limited during this cycle and included:

- 6' (or less) tall fences are exempt from permits (must still meet requirements of Chapter 165.23 of the City Code)
- Requires rental inspection of any non-owner-occupied dwelling unit
- Increased snow loads on one- and two-family dwellings, wind speed stayed the same
- Multi-Family and commercial building wind and snow loads are calculated using an ASCE Hazard Tool
- Receptacles (outlets) in a kitchen are not allowed to be located below the countertop

Maintaining current codes is important to the construction industry and for public safety. Updated codes facilitate the appropriate use of new materials, new methods and new technologies while keeping public safety, health and sanitation the main goal for these regulations.

ALL RENTALS NOW REQUIRE REGISTRATION AND INSPECTION

Effective January 1, 2026 all non-owner-occupied dwelling units are required to be enrolled in Hiawatha's rental program and have required inspection for minimum life, safety, and health standards. Prior to the amendment to Chapter 163 (Hiawatha's Housing Code) short term rentals (less than 30 days) were not required to be enrolled in the rental program.

NEW! IMPORTANT INFORMATION ABOUT HIAWATHA WATER PAYMENT SOFTWARE

Hello Hiawatha Residents and Businesses,

The Water Department is excited to announce that we will be implementing new online payment software in January 2026. While we are excited for the new software, we understand that with new software, minor hiccups may arise. We assure you we will do our very best to make this transition as smooth as possible for everyone!

With that, as of January 1, 2026, our current FrontDesk payment portal will no longer be accessible for payments. The same goes for automatic withdrawals (ACH) on January 15th. We will need to transition to the new Caselle payment portal as soon as it is active. While we do not know what that will look like at this time, we wanted you to be informed before the process changes. With the new software, customers that use online payments or ACH will need to create a new account and re-enter your payment information. Please keep an eye out for further information as the new year approaches.

Please know that we are very excited for this new chapter and look forward to a smooth transition. We thank you, in advance, for your patience and understanding.

ENGINEERING UPDATES

Guthridge Park Pickleball Courts will remain open and available to the public throughout the winter months pending no ice or snow on the courts. If there is snow or ice on the courts, the gates will be locked. This is a city investment and we do not want any damage to the playing surface due to snow shovels or snow blowers. Please help us protect this investment. Due to the usage of the new pickleball courts and mini-pitch, the City will be constructing a new restroom facility near the two courts in the early spring. The facility will be a prefabricated concrete structure that will arrive as one unit and placed on a foundation wall. The restroom facility will have two unisex restrooms with locking doors. Staff will work with a contractor to install a new sanitary sewer line out to Emmons St as well as provide electrical to the facility.



2026 Street Improvements

The city is looking to upgrade the following streets in 2026: N 10th St from Emmons St to Lyndhurst Dr; E Clark St from Center Point Rd to B Ave; E Willman St from Center Point Rd to B Ave. The city will be adding subdrain behind the back of curb on these streets if it is not already in place. Residents may see City staff are surveying these streets and up to 15' behind the back of curb. Staff is looking to add a sidewalk on E Clark St and/or E Willman St to allow for better connectivity between Tucker Park and the downtown as well as the Public Library. Residents that may be impacted by the sidewalks will be notified.
