## Hiawatha Water - Day and Night





The Hiawatha Water Department employees work day and night to maintain the water mains that serve the City. You may not realize this, but the employees in the Water Department get called out for emergency work at all hours, even weekends and holidays.

The majority of water main breaks come with the changing of the seasons and as we move through the winter. They come at the most inopportune times, such as night, on the weekends, and of course when it's very, very cold outside. So when you see the flashing, yellow lights, hear the Rata-Tat-Tat of the concrete breaker at 2:00 in the morning, or you are temporarily out of water, then it's probably the Water Department repairing a broken water main near your home.

#### **Economic Development in Hiawatha**

Most recently, an economic development group was formed, the Hiawatha Economic Development Corporation (HEDCO). Their mission statement is to develop a vibrant Hiawatha Economic Development Community utilizing - Public/Private Partnerships.

HEDCO consists of a 10 member board; 1-council member, 7-business owners and 2-developers. Each of their goals is to consistently maintain and sustain current commercial businesses and to promote new commercial development in areas the City of Hiawatha lacks. As Mayor, I have been a strong supporter of commercial development in our City for many years and that is why HEDCO will be a strong asset to economic development in our community along with several other factors, such as I-380 and the Tower Terrace Interchange.

In the past, I-380 played a significant role in developing our community. With the new road, the City began to grow from mostly residential homes to attracting commercial businesses. Companies wanted easy access to the nation's interstate system and we had the land and the access. We also had excellent developers that recognized our City's potential and brought companies to our vital city. As I-380 played a significant role in our growth, so will the Tower Terrace Interchange in respect.

As a City, we are often complimented on our "easy to work with" attitude, I like to call it our Partnership Attitude. Let me explain what I mean by partnership. From time to time, companies have to come to us and asked if there was some way the City could help temporarily offset some of their costs when moving their business to Hiawatha or as an entrepreneur starting up their new business. New buildings and massive moves become very costly and sometimes are what holds them back from moving forward. So with Hiawatha's "can do" spirit, the City created an economic development tool that we call "Tax Increment Financing" (TIF) that allows us to rebate a part of the new company's property tax for a short period of time with long term benefit for the City. This has worked very well for the past 22 years.

City sponsorships are another tool available to companies, such as the Midwest Disaster Bonds program. This grant was issued by the United States Congress allowing a company to apply for low interest loans. Additionally, there are state financial assistance programs in conjunction with educational training programs administered through our area's community college.

Economic Development is a wonderful tool for the City; it supplies us with a well rounded community that is not solely dependent on residential property taxes. Commercial development adds a great tax base and brings individuals to our community not only to work but to provide services that are needed in a community.

#### HEDCO's logo contest

HEDCO is a newly formed entity with a vision to further Hiawatha by encouraging economic development. The name is an abbreviation of the full legal name; the Hiawatha Economic Development Corporation. HEDCO will encourage development by engaging prospective businesses more completely, by marketing the community, by more completely identifying resources, and by creating public-private partnerships on key projects.

**Q:** Why is it important to encourage economic development? **A:** The cost and quality of life for residents is dependent on local economic conditions. By encouraging development in Hiawatha instead of one of the many alternatives, revenue is created to fund local services

Q: Why is another entity needed to encourage economic development? A: HEDCO will focus on issues important to Hiawatha while supporting broader efforts. Hiawatha is blessed to be part of a group of communities that are so involved in development, so encouraging economic development is not a new idea in Hiawatha. Q: How do I get involved in HEDCO? A: One way to get involved is by sending your ideas for a HEDCO logo. HEDCO is only recently formed and is actively working to generate a visual identity. Your help in designing a logo would greatly help our efforts. The contest winner will receive a ride on a City of Hiawatha Fire truck. #### History Commission - Hiawatha School

The History Commission reminisces Hiawatha Schools. The first Hiawatha School was a country school built in the early 1900's, named the Center School #4. This school was located at approximately 1077 N Center Point Rd in Hiawatha. The average number of students attending Center School #4 was about 18. "After I graduated from Center School, a second building was moved onto the property to handle the extra students moving to the area". - Theresa Zeman Larson (photo to right was taken in 1938)

The Hiawatha School opened in the fall of 1958 with thirteen classrooms and an enrollment of 350 students in grades K-6. The cost of construction was \$17.52 per square foot and the total cost of construction was \$529,051. During the 1970's the school changed from a rural school to a small town school. In the 1980's its families became a combination of rural, city, and acerage



dwellers. Over the years, many other changes have taken place at Hiawatha School. Trees have been planted, the front drive widened, playground drainage problems worked on, and classrooms added. In 2011, there are approximately 460 students at Hiawatha School in grades Preschool - 5th. A fitness trail, new computers, and new playground equipment have recently been added.

When Nixon School opened in 1970, surrounded by corn fields and dirt roads, a tree donated by President Nixon was planted to commemorate the event. Nixon was designated to accommodate the open space instructional concept. The instructional strategy was called I.G.E. (Individual Guided Instruction). Changing expectations have resulted in many changes in the facility. Walls have been put between classrooms and lockers have been moved to the classroom areas. Future plans include the development of a fitness-science trail that can be used by the community. Nixon is a place where learning occurs, and students are prepared to confront a future they will create. Enrollment at Nixon for the 2010/11 school year is approximately 325 students Preschool-5th grade.

#### Linn County Crime Stoppers granted 501c3 Status

The newly formed Linn County Crime Stoppers has been notified by the Federal government that the organization has been granted tax exempt status. "This is an important step for this new organization" explained Chairman Marty Bruns. "This status will allow us to begin the process of raising funds to support the rewards that are given to citizens when the information they provide assists area law enforcement agencies in apprehending criminals."

All reward funds for Crime Stoppers are raised from businesses and individuals who want to support the work of this grass roots organization. Crime Stoppers expanded to all of Linn County at the beginning of 2010. A board of directors consisting of representatives from all Linn County towns and rural Linn County has worked throughout the year to set up the organization and to gain exempt status. Chairman Bruns went on to explain, "Now that this status has been achieved, the real work of the organization can truly begin. We are asking folks to help law enforcement agencies by being their eyes and ears in the community. When a person assists law enforcement by providing valuable information they should be rewarded, and this organization is the vehicle that can deliver that reward completely anonymously.

Linn County Crime Stoppers is cooperating with all of the law enforcement agencies in the county including, Cedar Rapids Police Department, Marion Police Department, Lisbon and Mount Vernon Police Departments, the Central City Police Department, Hiawatha Police Department and the Linn County Sherriff's Department. If any citizen has information concerning a crime that has taken place anywhere in Linn County they can call the Crime Stoppers number - 1-800-CS-CRIME - to receive a number that will allow the citizen to keep track of their tip to see if it led to an arrest and would qualify for a reward.

"We appeal to all business owners and individuals who want to insure that we keep criminals off the streets and keep businesses and the public safe," explained Chairman Bruns. Tax deductible contributions can be made to the Linn County Crime Stoppers organization by sending checks c/o Cedar Rapids Police Department, 505 1st St. S.W., Cedar Rapids, Iowa 52404-2103. "I want to emphasize that this is a community wide organization" continues Chairman Bruns. "The Cedar Rapids Police Department has volunteered to be the permanent address of the group, but this is truly a county wide organization with cooperation from all Police Departments as well as the Sherriff's Department. If you see crime anywhere in Linn County, we want to know about it."

#### **Driving Responsibly: A Sobering Reminder**

Remaining vigilant of our responsibilities as licensed drivers is an obligation we have to ourselves and our community that has to be revisited from time to time. Unfortunately, it is easy to become too comfortable with driving and forget that the privilege of being a licensed driver in lowa comes with great responsibility.

According to the Governor's Traffic Safety Bureau, the leading cause of death for lowans aged 16-20 is fatal car crashes. The lowa Department of Public Health identifies injuries from motor vehicle accidents as the leading cause of death for those aged 1 to 34 years and 55 to 64 years.

Some of the most significant contributing factors identified by the Governor's Traffic Safety Bureau are: distracted driving, texting while driving, alcohol use, speeding, no seatbelt, and inexperience.

You may also be surprised to learn the amount of traffic in Hiawatha. The lowa Department of Transportation reports that 3,940 vehicles pass by Hiawatha Elementary every day on Emmons Street. Another 42,600 vehicles pass Emmons Street on Interstate 380 every day. Moreover, the United States Department of Energy reports that in 2006 the average weight of a light-duty truck is 4,712 pounds and the average weight of a car is 3,563 pounds. With the amount of traffic and sheer weight of that traffic, your efforts to focus on your driving and the driving of those around you is paramount. As always, obey the posted speed limits, wear your seatbelt, and refuse to drink and drive. Parents, please be thorough in the training and experience your child has before you give the responsibility of driving to them.
