Library Offers Tax Help From the AARP



Tax preparation aid is available from the AARP at the Hiawatha Library. This free tax preparation is for taxpayers with low to moderate income, without restrictions on age (giving special attention to people over age 55), and e-filing is available at no cost. History Commission Remembers Tucker Park

Wesley "Tom" Tucker owned the original Lutz farm located on the Northeast corner of Center Point Road and Blairs Ferry Road. It is now the location of the office/business complex. The park was a timber of walnut trees.

During the 1950's, the Hiawatha Optimist Club was organized and the members volunteered to clear the land and make it into a park. With much volunteer help from the Club members, they cleaned out the weeds and shrubbery, then tackled trimming the trees and ended up with a huge pile of brush. The members then decided to have an old fashioned wiener roast and picnic for work well done. They set the brush afire and had a very large, hot fire, so hot the members laid behind empty 50 gallon drums to roast the wieners. One HOT fire!

The City leased the land for \$1.00 per year before taking ownerhsip of the park,

which was named Tucker Park, in honor of Mr. and Mrs. Tucker.

The City dug out an area for the Hiawatha lagoon system that was the start of a sanitary sewage system through the gravity and lift station operation. Later in 1965.

it became the Cedar Rapids Dry Creek Sewer System. With the closing of the lagoon, the Hiawatha Fire Department made an ice skating rink out of that lagoon area, much to the enjoyment of the residents. Over the years, rest rooms, playground equipment, pavilions, a splash pad and parking area were added. This was a great start for the Hiawatha Park System.



Finance Department - What We Do

The Finance Department consists of a Finance Director, Cindy Kudrna, who has been with the City of Hiawatha for nearly five years. The Finance Department is responsible for the accurate and timely recording of all financial transactions of the City and safeguarding the City's assets. Pursuant to the Hiawatha City Code, the Finance Director is the accounting officer and treasurer of the City and is responsible for all financial aspects of the City including:

- Preparing and monitoring the annual budget and the five year capital improvement plan (CIP)
- Providing financial information to the Mayor, the City Council, City Departments, and Citizens
- Developing and ensuring compliance of internal fiscal control policies and procedures
- Preparing monthly finance reports by fund
- Preparing and filing State and Federal financial reports
- Monitoring cash flow and investing City funds accordingly
- Processing accounts payable and reconciling the procurement card program
- Being the main contact for the annual audit
- Assuring compliance with State and/or Federal grants
- Keeping financial records including: Special assessments: TIF development agreements and rebate schedules; All debt issuance and obligations; Liability insurance policy and claims.

Redistricting/Reprecincting

Lines have been drawn and polling locations are established!

The Linn County Auditor's Office has established Hiawatha area precinct and polling locations. In September's newsletter, we shared with you the need to re-establish our precinct boundaries due to the federal decennial census with a population increase of 7024. Based on lowa Code, each precinct could not be larger that 3,500 in population and has to be determined by a census block. Upon review, we were instructed by the lowa Secretary of State and the Linn County Auditor's Office that it was necessary for us to re-precinct into four (4) precincts. Precinct boundaries were drawn as demonstrated on the map along with polling location keys.

Polling locations are as follows:


Precinct #1 - Hope United Church of Christ - 150 Ninth Avenue (color blue on the map)

Precinct #2 - Hiawatha Community Center - 101 Emmons Street (main level) (color red on the map)

Precinct #3 - Hiawatha Multi-Purpose Room - 101 Emmons Street (lower level)(color green on the map)

Precinct #4 - King of Kings Lutheran Church - 3275 N Center Point Road (color yellow on the map)

A county-wide mailing of new voter ID cards will be mailed in Mid-February to all actively registered voters. This will be coordinated by the lowa Secretary of State's Office along with press releases to help spread the word about precinct and polling place changes during the month and the days/weeks leading up to the Local Option Sales and Service Tax Election held March 6, 2012.

Hiawatha Library Annual Report

The Hiawatha Public Library presented its annual report to the City Council on January 4, 2012. The library circulated 304,123 items in FY11 which represents a 5.7% increase over the previous year. Circulation has climbed from 122,928 in 2001. The library has the highest circulation for cities its size in the entire state. Circulation per capita for the Hiawatha Library is 44.4, compared to North Liberty's 29.32. The library has 7.3 full-time equivalents for staffing.

By the numbers:

Circulation: 304,123 items checked out

Technology: 22,672 people used computers for 16,765 hours

Fun: 10,890 children and teens attended library programs while 704 adults participated in adult programming

Meetings: 1,057 groups met in the library meeting rooms

Volunteers: 670 hours of volunteer time Book Clubs: 4 book clubs with 54 members









Employee Safety Day



In our efforts to provide a healthy and safe environment for our valuable employees, the City held a "Stand Down" safety training day, on November 3, 2011, for all 46 staff members to attend, drawing attention to workplace safety.

The day was filled with several classes: some demonstrated new ideas about making the City a safer place to work; refresher courses; and recognized previous accomplishments regarding safety.

By providing safety awareness, it will lead to better practices, which will ultimately keep our employees safe, reduce lost time for employees, worker's compensation claims and the cost of insurance premiums.

Neighborhood Watch/Crime Prevention Signs

You will begin to see new Crime Stoppers signs being placed around not only Hiawatha but all cities within Linn County. Linn County Crime Stoppers is a "tip line" set up to receive information on criminal activity and assist local law enforcement with identifying individuals and/or vehicles associated with a crime. From time to time, you may see a picture in the local newspaper or on the evening news asking for the public's help. If you have specific knowledge of the event, you may provide that information, while remaining anonymous. You simply call the number and provide as much information as you know about the incident. You will be given a unique identifier for the information you provided. If the information you provided assisted law enforcement, you may be entitled to a cash reward.

Crime Stoppers information is not limited to only those incidents you see in the media. Information on any other criminal activity can also be reported. Again, if the information you provide assists law enforcement with solving a crime or making an arrest, you may be entitled to a cash reward. Crime Stoppers is a "tip line" and generally should not be used for crimes that are in progress. In progress crimes should be reported to your local police department immediately.

The question has been recently asked about the difference, if any, between this and the Neighbor-

The question has been recently asked about the difference, if any, between this and the Neighborhood Watch Program. These two programs have the same intended result of making our community safer by becoming involved. The Neighborhood Watch Program is completely separate of the Linn County Crime Stoppers Program. Neighborhood Watch is geared toward neighbors watching out for neighbors. Crime Stoppers is a way for citizens to provide information about criminal activity anywhere in Linn County while remaining anonymous.



Pollution Prevention Center Going Appointment Free!

The Cedar Rapids/Linn County Solid Waste Agency is making it easier for Linn County residents to recycle household hazardous materials like oil-based paints, cleaners, and lawn and garden chemicals. Starting January 3, 2012, the Pollution Prevention Center, which accepts household hazardous materials for free from Linn County residents, has gone appointment free!

Since 1996, Linn County residents have had to make an appointment to drop off unwanted paint, chemicals and cleaners. Now thanks to an increase of trained staff, those items can be dropped off whenever the Solid Waste Agency facility at 1954 County Home Road, Marion, is open. Hours are 7:00 a.m. - 4:30 p.m., Monday - Saturday.

"We are glad to be able to offer this service to all Linn County residents," said Karmin McShane, Solid Waste Agency Executive Director. "Going appointment free will make it easier for residents to use the Pollution Prevention Center whenever their schedule allows and helps the Solid Waste Agency's resource recovery efforts."

All items that are dropped off at the Pollution Prevention Center are inspected. Those that can still be used are placed in the Swap Shop. All Swap Shop items are available free to Linn County residents and can be taken whenever the Agency is open.

The services offered by the Pollution Prevention Center are completely subsidized by the Solid Waste Agency. Despite being a government entity, the Cedar Rapids/Linn County Solid Waste Agency does not receive any taxpayer dollars. All services, programs, and operations are funded by landfill tipping fees.
