Emerald Ash Borer

The Emerald Ash Borer (EAB) beetle had been found in Linn County at a rest stop on I-380 just north of Johnson-Linn county line. This was confirmed by Iowa Department of Agriculture and Land Stewardship on October 19, 2015.


The EAB is a small green invasive wood boring beetle that attacks and kills ash trees. The adults live on the outside of ash trees feeding on the leaves during summer months. The larvae look similar to white grubs and feed on living plant tissue underneath the bark of the ash trees. The trees are killed by the tunneling activity of the larvae under the tree's bark, which disrupts the vascular flow.

The City of Hiawatha is currently working on developing a tree management plan with the help of the Iowa DNR and the Sustainable Tree Grant who provide education and training on how to retain and grow a healthy tree stock during the 2016 year.

For the time being, residents should be informed about what they can do to start taking action to protect their ash trees by evaluation. Look for thinning or dying branches, water sprouts half-way up the trunk of the tree, feeding notches on the edge of leaflets, woodpecker feeding sites, many bark flakes on the lawn, S-shaped feeding galleries under the dead bark and D-shaped exit holes. These are all major signs of an infected ash tree(s). Cities are responsible for trees in the right-of-way where residents are responsible for trees located on their personal property.

To stop the spread of the EAB there are two (2) options residents have. As a resident you can have affected trees treated with insecticide usually applied by a commercial pesticide applicator. This option is available if tree(s) are relatively healthy, vigorously growing and valuable to your landscape.

The other option available to residents is to arrange for the affected tree(s) to be removed. Residents can contact commercial tree removal services to assist in your tree removal.



Start of Construction on the Water and Sewer Extension to New Annexed Area

The contractor for the water main and sanitary sewer extension project along Edgewood Road (formerly Loggerhead Road) has begun construction. The construction extends from the intersection of Fitzroy Road north to the newly annexed property of County Home Road and east of I-380. The project includes approximately 6,000 feet of 12 inch water main and 4,000 feet of sanitary pressure line. Also included is a new lift station north of County Home Road.

Ricklefs Excavating Inc. from Anamosa, Iowa was awarded the \$1,300,000 contract in November of 2015 which has been funded with Capital Project Funds and Local Option Sales Tax Funds. The schedule for the project anticipates completion and service by the fall of 2016.

This project will provide water and sewer service to over 100 acres annexed to the City of Hiawatha in late 2014. The total area that could be served with this project in the future exceeds 300 acres. The City has scheduled an update to the current comprehensive plan in 2016. The update will include indentifying future land use anticipated in this area.

Smoke Detector "Blitz"

On January 9, a crew from the Fire Department performed a smoke detector "blitz" in the Sunset Village neighborhood. This neighborhood was the location of a recent major house fire. The firefighters went door to door offering the residents their assistance and expertise in checking smoke detectors. Members changed batteries in smoke detectors and also installed new detectors in



numerous homes that did not have working smoke detectors. They also offered a home safety check and answered any fire related questions. Preventing fires and emergencies is a mission the Fire Department takes to heart. Ryan Neuhaus, one of the firefighters that assisted with the event said it best, "The most important thing we can do when not on a call is prevent the next one. On a cold day it was heartwarming to know we may have given a family the extra minute or two they need to get out in the event of a fire. For every battery and detector we installed, we helped to protect a family 24 hours a day. It really multiplies the impact the Fire Department can have on the community."

Smoke detectors save lives and give you the needed time to escape your home in the event of a fire. Please remember to change the battery in your detector once a year and test it monthly to ensure it is in working order. Not many people realize that smoke detectors have a recommended life span of 10 years, detectors older than 10 years should be replaced. If you ever have any questions or need assistance with your smoke detectors please call the fire station and we will be more than happy to help you.

Fluoridation

Hiawatha Water Department has been adjusting the fluoride in the drinking water since 1980 when we received a grant from the Iowa State Health Department. A public hearing was held to get



input from the community and no objections were received.

After 35 years of adjusting fluoride in the drinking water; the Water Department is again asking for input from its Hiawatha residents. You will notice in the message line of your **February** water bill a question regarding fluorinating the water. We are asking you to answer the question: Should we continue fluoridation? Please answer the question on your billing stub by marking YES, NO or INDIFFERENT. Please return the bottom portion of your water bill as you normally would. If you are an ACH or e-billing customer, you can place your response in our after hours drop box.

These free public forums are a venue for state representatives and senators to discuss issues of concern and to answer questions from constituents. In addition to the January 16 event, other forums will be February 20, March 19 and April 16. All of the 2016 forums are in the Mercy Medical Hallagan Center from 10:30 to 11:45 AM.

The League of Women Voters of Linn County conducts the forums as part of its voter education program. The League of Women Voters Linn County is a non-profit, non-partisan volunteer political organization that encourages citizen participation in government.
