# State of the City Address

2010 was a good business year for Hiawatha. We received very good news in March, when we heard "Go Daddy" had decided to come to Hiawatha with a five year projection of 600 new jobs. After some remodeling of the building at One Parsons Drive, the official Grand Opening was held on July 8, 2010.

In May, CCB Packaging announced a 40,000 sq. ft. warehouse expansion and a 6,000 sq. ft. corporate office facility. They also added 40 new employees.

In September, Ahmann Design began construction on a new office technical center. This facility will bring one new business to town and allow an existing Hiawatha business to expand and add new employees.

PAETEC has decided to move into a new facility on North Center Point Road. The move will sustain approximately 400 jobs in Hiawatha. Your City Council was very aggressive in attempting to keep them here and we are pleased with their decision.

In November, the City received its first R.I.S.E. grant of \$1.4 million to help reconstruct almost three quarters of a mile of North Center Point Road from Stamy Road to Tower Terrace Road. When this street is completed, it will be three lanes wide with sidewalks and streetlights. The total estimated cost is \$2.9 million and project completion date is November 2011.

Tower Terrace Interchange is still on our radar. We continue to aggressively meet with the I.D.O.T. to present our City's needs and the advantages the interchange will play in our community and the communities of Robins, Marion and Cedar Rapids. Recently the Corridor Metro Planning Organization approved an amount not to exceed \$250,000 to help pay for a new Interchange Justification Report.

The City has invested \$2,674,771 in water, sewer, storm and street infrastructure.

**Sewer:** \$1,145,794 includes Northwest Sewer main extension, Manhole reconstruction, Sanitary Sewer miscellaneous repairs, North Center Point Road Sewer extension and catch basin repairs.

**Storm Sewer:** \$207,287 includes Heritage Green Creek, Thiher Drive Draintile and Litchfield Drive/Boyson Road Draintile projects.

**Streets:** \$414,761 includes Third Avenue from Clark Street to Marion Street, C Avenue from Blairs Ferry Road to Tucker Street and Crack Sealing.

**Water:** \$906,929 includes Northwest Water Main extension, Third Avenue from Clark Street to Marion Street and North Center Point Road Water Main extension.

Property acquisition has begun on the Boyson Road project. Utility work and talks with the railroad will continue in 2011. This is a large project that will take several years to complete.

The City recently bought Oakbrook trailer park and has requested proposals from qualified developers. The Council has many options available to consider and we will keep you updated as this project develops.

As you may remember, we had a 350 acre voluntary annexation in 2009 and recently started another new annexation project of about 100 acres. This is also totally voluntary. With the 2009 annexation, the Council approved the subdivision final plat for Pines at Turtle Creek. This subdivision is plotted for 104 lots and basements have been poured for the first two homes.

Hiawatha has a new Economic Development group of business leaders that want to help the City to prosper. Their name is HED-CO which is short for Hiawatha Economic Development Corporation. Their mission statement says "Develop a vibrant Hiawatha economic development community utilizing public and private partnership." HEDCO is a volunteer driven organization committed to delivering services and results in the most efficient manner. They have a board of directors, slate of officers and will meet each month. HEDCO hopes to make Hiawatha the first choice for realtors and developers.

City staff has diligently worked on two vital aspects of city planning, they are our Comprehensive Plan and Design Guidelines. Both documents will keep the City within their boundaries and continue to unify the development layout and aesthetics of our City. Both documents are futuristic but necessary to ensure continuity and eliminate any hodge podge.

As you can see, we have had a busy 2010 and anxiously await what 2011 will bring our way.


## Local Option SalesTax Dollars Update

2010 has been a very busy year for the City of Hiawatha. We received approximately \$881,000 in Local Option Sales Tax dollars. With the additional revenue we were able to make many improvements throughout the city including water and sewer mains, drain tile installation to help with storm water maintenance, park improvements, police and fire equipment, seasonal decorations, library improvements and street reconstruction.

As you can see from the chart, about 45 percent of the LOST dollars were used on street improvements. Here is a summary of the Public Improvement Projects that were completed this year.

- 1. C Avenue from Blairs Ferry Road to Tucker Street included pavement replacement, manhole repairs, and drain tile installation. The project is complete and the final contract amount was \$113,549.
- 2. Third Avenue from Clark Street to Marion Street included pavement replacement, water main replacement, storm sewer and drain tile installation, and sanitary service repairs. The road is currently open. The project is about 75 percent complete, with grading, seeding and storm sewer intake work to be completed next spring. The contract bid amount is \$281,068.
- 3. Water and sanitary sewer mains are extended on North Center Point Road from Tower Terrace Road north to the City limits. LOST funds helped pay for sanitary sewer construction on the east side of North Center Point Road. The project is complete and the final contract amount was \$195,108. LOST funding accounted for \$90,050 of the total project costs. The remainder of funding was paid by the water utility, special assessments, and TIF.

LOST dollars were used in many other areas around the City. If possible, we have put up signs showing the projects that were funded with LOST dollars. You may have noticed these around Hiawatha in the parks or along the roadway. With the addition of LOST as a source of revenue, the City has been able to do some of these improvements that may have been delayed due to the lack of funding. So, thank you to our voters, we were able to do these projects, along with others we are planning for the future to make your City the best it can be.

# **History Commission - Police Department**

In the early start of Hiawatha, late '40's and early '50's, there wasn't an appointed Police Chief. But, Fay Clark did appoint Ron Wagner as "Marshall" and Bob Cook as "Assistant Marshall". They didn't have any special training except coming back from Wold War II, which was training enough in those days. So there were weapons carried.

The first squad car was Fay Clark's personal car, which was a late '40's Packard. A Dodge in the '70's that spend a good deal of time in Dick Larson's garage where he kept it in good working condition. Especially the muffler system, so you knew it had some

rough times on rough roads!

Fay Clark invented a "speed trap" in a certain area of Highway 150. An electronic tape would lay across the highway up to a flip-up sign which said "Stop!" Going too fast from point A to the "Stop" sign at point B would get you a speeding ticket.

Calling the Police or Fire Deptartment was a "calling tree." Fay or Adaline would be the first ring. If it would go unanswered by the

fourth ring, then the caller would move down the list. The one receiving would then call the next one on the roster and so on. The first Police Station was located in the City Hall complex along with the Water Deptartment, Fire Deptartment, and Library. After remodeling the lumber company into the City Hall expansion, the Library and Police Deptartment would be housed there. Today, there are 8 full-time officers, one officer designated to a K-9 unit, 3 sergeants, one administrative assistant and a police chief.

Ron Wagner - Marshall (1953-58); Pat Clark - Marshall (1958-62);

Neil Willia - Chief (1962-66); Robert Quimby - Chief (1967-68); Ormal Williams - Interim Chief (1968-69); Doug Stowell - Chief (1970-73);

Dave Saari - Chief (1973-03); Rick Pierce - Chief (2003-07);

Gary Manhart - Interim Chief (2007); Dennis Marks - Chief (2007-Current).

The Hiawatha Police Department is based out of the west side of the new City Hall, lower level. The department is secured from the other areas of City Hall. The station features two interview rooms with video capability, an evidence storage room, a secured armory for weapons and ammunition storage, a command center for multi-jurisdictional emergency response personnel in the event of a disaster.



# **Speed Zone Ordinance**

New speed limit signs are now appearing in our Commercial/Industrial Districts. We responded to a request from an area business owner to post more speed limit signs. While researching this request, it was discovered that we really did not have many options under the current City Ordinances or State Law. The city engineer reviewed all roads encompassed in the new districts. It was discussed at Council level and decided that 30 mph was a reasonable and prudent speed for this area. While not every road section in the Commercial/Industrial districts will have a new speed limit sign, the entire district is 30 mph unless otherwise posted. New signs will be posted in the area north of Boyson and east of North Center Point Road and north of Boyson between Miller Road and the Interstate. Please observe the new posted speed limits.

Chapter 63 SPEED REGULATIONS

63.05 COMMERCIAL/INDUSTRIAL DISTRICT. A speed in excess of thirty (30) miles per hour contained within any commercial/ industrial district, unless specifically designated otherwise in this chapter, is unlawful.

63.10 SPECIAL 25 MPH SPEED ZONES. A speed in excess of twenty-five (25) miles per hour is unlawful on any of the following designated streets or parts thereof.

- Stonegate Court from Robins Road to the end of court;
- 2. Twelfth Avenue Court from Boyson Road to court;

# Boyson Road/Robins Road Intersection

In the 2011 construction season, North Center Point Road between Stamy Road and Tower Terrace Road will be reconstructed. The finished product will be a concrete street with curb and gutter, center turn lane, storm sewer, and sidewalks. Prior to the City receiving a state grant for this project, the City scheduled the reconstruction of Boyson Road between Hawkeye Drive and Robins Road in 2011. However, to avoid disruptions to two neighboring major streets at the same time, Boyson Road paving will occur in 2012. The Boyson Road project will not be entirely on hold though. Right-of-way acquisition, grading and utility relocations are still expected to occur in 2011, in preparation for the paying in 2012.
