NIXLE.com

Hiawatha has launched a new Community Information Service designed to deliver important and timely information to residents in our area using the latest technology. This service, Nixle, delivers trustworthy and important neighborhood-level public safety and community event notifications instantly sent to you by cell phone text message, email, and the web. Nixle is completely free to both the City and to the end user (standard text message rates apply for cell phone subscribers who do not have text plans with their cell phone providers).

The Police Department, Fire Department, Water Department, and City Hall all have the ability to enter information. This information is loaded and controlled directly by the city. We control the content and the messages. There is no “spam” or advertising-it is all local content. With this, we will be able to deliver messages on road construction, water main breaks, public safety information, concerts and community meetings to you in a timely fashion. You control which level of message you receive and how.

Nixle works like this: Go to the website to sign up. There you choose when and how to receive messages. Typical messages come in two forms. The first form is as a short message. The second message contains more detail. It will normally be in a format similar to a press release. When we input a message, it will be delivered to the email address and or cell phone number you choose.

Recently you may have heard of other services that you can sign up through Linn County, including “Code Red”. Those services call your number and leave you a voice message. They are for more severe safety issues, such as a flood or large evacuation, and is tightly controlled by the County 9-1-1 centers. We encourage you to do that, Nixle will allow us to deliver time sensitive information, about Hiawatha, directly to Hiawatha residents and others who sign up for the information.

You can sign up at www.nixle.com. Click on the “Register Now, it’s free and easy!” Remember, you must have a Hiawatha Address for the system to deliver information to you. The system gives you the options of registering alternate address points, such as a work address, if needed.



Hiawatha Census 2010

The 2010 census is a count of everyone residing in the United States. Soon every household in the country will receive a questionnaire in 2010. To ensure an accurate and fair count of all populations at all geographic levels in the nation, the Census Bureau needs you or someone in your household to respond to the census questionnaire.



1. **It's important.**—Census data affecting funding for your community, your community's representation in Congress and your community leader's planning decisions.
2. **It's easy.**—The census questionnaire takes only a few minutes to answer and return by mail.
3. **It's confidential.**—Your responses are protected by law (Title 13, U.S. Code, Section 9). All Census Bureau Employees have taken an oath to protect confidentiality and are subject to a jail term, a fine—or both—for disclosing any information that could identify a respondent or household.
4. **It's required by law.**—The information you provide is combined with responses provided by your neighbors and other households across the country, to provide summary statistical data that are used by various local, state and federal agencies.

It's important.—Census affects funding in your community.

Census data directly affect how more than \$300 billion per year in federal and state funding is allocated to communities for neighborhood improvements, public health, education, transportation and much more. That's more than \$3 trillion over a 10-year period. Spending just a few minutes to fill out your census form will help ensure your community gets its fair share of federal and state funding.

The meeting was sponsored by the Cedar Rapids Area Chamber of Commerce and the key speakers were Shannon Meyer, President and CEO and Allen Witt, Board Chair. They explained how the Chamber can help businesses locally and how they may be able to help with their Washington D.C. trips. Notice of Water Rate Increase

NOTICE TO WATER CUSTOMERS

Effective July 1, 2009, the Hiawatha Water Board has increased water rates by the minimum rate of 3%. The new water rates for the first 1000 gallons are as follows:

The Commodity Charge has increased \$.20 from \$3.07 to \$3.27 per 1000 gallons thereafter the first 1000 gallons. The rate increase will additionally be reflected in your sewer usage.

EYE-380 Grant

Landscape workers have installed a variety of shrubs and flowers at the southwest quadrant of the Interstate 380 Boyson Road interchange in Hiawatha, a design that may become a model to beautify the freeway at a number of locations in the Cedar Rapids metro area.

The planting, approved last fall by the Hiawatha City Council, was made possible by a grant from the roadside improvement fund of the Iowa Department of Transportation (IDOT). IDOT officials, led by Mark Masteller, worked with the Hiawatha Parks Dept. and Eye-380, a volunteer group seeking ways to beautify Interstate 380 in the metro area.

Angie Cole, Director of the Hiawatha Parks Dept. and a member of Eye-380, said planning for the project began in late 2007. Eye-380 members, meeting at Trees Forever offices in Marion, were also aided by horticultural



students at Kirkwood Community College. The final design, she explained, was produced by the volunteer work of Eric Shepley, a landscape architect at Hall and Hall Engineers in Hiawatha.

All of the plants used at the Hiawatha site meet the IDOT requirements for Iowa roadside hardiness and compatibility with traffic safety. The design incorporates heavy use of native species. After a two-year establishment period, the maintenance of the plants becomes the responsibility of local sponsors. Similar projects have been undertaken in other Iowa cities.

The next step will be to determine interest in duplicating the Eye-380 design at other locations along the interstate through Cedar Rapids. Shepley said long-term annual maintenance costs are estimated at \$750 per site. The Eye-380 committee hopes individuals, organizations and companies will support the interstate roadside improvements. Contributions may be sent to Eye-

Ever-Green Landscape Nursery & Supply planted the Boyson Eye-380 shrubs and grasses. Initial maintenance will be done by Creekside Gardens.



Summer showers—Storm water

The summer showers will be a welcome change from all of this snow and ice. When it rains, the storm waters end up back in our water sources. The storm drains lead to lakes, streams, and rivers. Storm water transports pollutants into our drinking and recreational bodies of water. So please help protect our water quality by following a few simple rules.

1. Grass and weeds should be kept at 8" or less. The recommended grass length is 3". When your lawn is 3" tall, it allows water more time to absorb into the soil versus running into the street or onto the sidewalk and towards the storm drains.
2. Grass clippings should never go into the street. This clogs storm drains and affects the quality of our water.
3. Direct your downspouts away from paved surfaces. All drainage needs to be dispersed on your own property. This helps to prevent pollutants such as motor oil or detergent from entering our water sources.

City Projects

Boyson Rd and Robins Rd Interchange/Realignment

Planned meeting with CN Railroad representatives in July to discuss the project and construction in the railroad right of way. The DOT is currently reviewing the Concept Statement submitted in May, the City will work with them in the coming months to obtain necessary clearances and proceed with project development.

Heritage Green Creek Maintenance Project

The public information meeting was held June 18, 2009. The City will be moving forward and obtaining the necessary easements and permits for the project.

Mitchell Drive Pump Station and Force Main Extension/Bypass

MidAmerican Energy completed the gas supply extension in mid June. The contractor is working to complete the gas connection to the generator. Once the gas connection is made, the pump station supplier will meet with City maintenance staff regarding the control and operation of the station. In the coming days, the contractor will complete final project cleanup and the City will begin project close out.



Northwest Sanitary Sewer and Water Main Extension Project

Preliminary design is currently underway. The City has contacted the DOT regarding crossing the Interstate 380 Right of Way and will be coordinating this work in the future. Hiawatha met with Cedar Rapids Engineering and is working out details on possible joint participation.

Park & Recreation Citizen's Survey 2009

In April, the Park & Recreation Department sent out 800 survey's and 183 were returned, giving the survey a 5.4% margin of error. Jeff Schott of the Institute of Public Affairs reviewed the survey with the Park and Recreation Board. Here are some of the results.

94% are satisfied/or very satisfied with the City Parks

99% agree that they like the overall condition of the facilities are in good or excellent condition

44.1% agree that more Multi-Purpose Trails are needed

65% have utilized the Farmers Market program

30.3% agree they want more adult fitness classes implemented

52.7% agree/strongly agree that the City needs a swimming pool facility

52.4% agree/strongly agree that the City needs a community recreation center


