Hiawatha Purchases Street Sweeper

In March of this year, the City purchased our own street sweeper. For the last 15 years, we have been contracting out for street sweeping. Similar to many other local cities, the City of Hiawatha performs what are called Best Management Practices to reduce the amount of pollution reaching our storm drains. Regular street sweeping is one of the most cost-effective Best Management Practices used to remove sediment, metals, petroleum

products, trash and vegetation which accumulates on streets. By purchasing our own street sweeper, we can improve our program and be more effective in removing debris from roadsides and gutters which could ultimately end up in the storm drains. Keeping the storm drains clear not only helps to mitigate water pollution, but also reduces the likelihood of flooding during heavy rain. We have already seen better results in a short period of time. The sweeper was purchased with Local Option Sales and Service funds.



Storm Water Rates

Tuesday June 18, 2013 the City Council set a public hearing date of July 3, 2013 at 5:30 p.m., to give notice to the Hiawatha citizens and business community that they will consider an ordinance amending Hiawatha City Code of Ordinances Chapter 99 Sewer Service Charges §99.02 Rate, increasing the sewer service charges from 105% to 107%, effective July 1, 2013, for August 2013 billing.

The increase will assist in the growing cost of maintenance, treatment, and disposal of our sanitary sewage within the City in order to protect the public health, safety and welfare of our citizens.

Project Updates

Boyson Road/Robins Road Update:

Boyson Road paving east of the Robins Road intersection, as well as driveways and sidewalk along this approach are complete. The intersection and Boyson Road to the west are nearly ready for paving, which should be complete in July. Storm sewer, water mains and traffic signal conduit have been installed. When all paving is complete, the remaining sidewalk and driveways will be finished. Final steps include grading, seeding, signs and traffic signals. The project is on schedule to be completed in September 2013.





The North Center Point Road from CC&P Railroad to Fisher Street Improvements project was started in April 2013 and will extend the four lane section ending just north of the railroad tracks to connect with the existing four lanes at Fisher Street. The project includes railroad crossing gates, decorative lighting, undergrounding of utilities and landscaping. After a slow start due to weather and utility delays, Ricklefs Excavating is now cruising along having installed most all of the underground utilities. Traffic has been diverted to the east side using temporary pavement in order to keep traffic flowing during construction. Included with the construction was a project to construct a 10-foot wide trail along the east side of North Center Point Road from Boyson Road to Stamy Road. This trail was completed in May 2013.

L.O.S.S.T Update

Since July of 2009, the City of Hiawatha has been receiving Local Option Sales and Service Tax (LOSST) dollars. As of June 30, 2013 we have received \$3,546,371.42 in LOSST funds. With the additional revenue, we were able to make many improvements throughout the City, including installment and replacement of water and sewer mains, drain tile installation to help with storm water maintenance, park improvements, police and fire equipment, seasonal decorations, library improvements and street reconstruction.

As you can see from the chart, about 57% of the LOSST dollars were used on street improvements. We installed an infrared traffic camera on the off ramp at Boyson Road to help with traffic flow. We buried utility lines along Stamy Road, along North Center Point Road and at the Boyson Road/Robins Road intersection. LED lighting was installed along North Center Point Road and Stamy Road. We reconstructed 3rd Avenue and C Avenue. We purchased two bus shelters, street holiday decorations, and a street sweeper.

The Hiawatha Public Library was able to purchase and install a Radio Frequency Identification Device (RFID) to electronically scan items being checked out, to help track books, CD's, DVD's, periodicals and other materials more efficiently, to better serve patrons by adding self-check stations and allow for the decrease in handling items for staff, with added security and inventory features.

The Police Department and Fire Department has also benefited from LOSST funds. The Police Department was able to purchase a new Chevy Tahoe for our K-9 and a new Dodge Charger for our investigator. Updates to the interview room and replacement of their computer server were also completed. The Fire Department did some building improvements, purchased Self Contained Breathing Apparatus (SCBA) equipment and a new light rescue truck with LOSST funds.

The Park and Recreation Department completed a Park Master Plan, installed a software program to allow patrons to register for recreation programs, rent a park pavilion, or rent the community center using the online Cogran system. Other improvements, in Guthridge Park new dugouts were constructed at the ball diamonds, a sunshade near the splash pad, park equipment, replaced the roof in the concession stand, applied a sealant to the parking lot and built a landscape planter. In Tucker Park, we built a landscape planter and applied a sealant in the parking lot.

Water and sanitary sewer mains were extended on North Center Point Road from Tower Terrace Road north to the City limits. The water main was replaced at the Boyson Road/Robins Road intersection along with replacement on 3rd Avenue and on E. Clark

Street. As part of the sewer main maintenance program, we televise a section of the sewer lines to inspect the pipes looking for infiltration cracked or broken pipes or roots from trees that sometimes appear i the lines. The erosion repairs at Ushers Creek area was a project the also was completed.

June 30, 2014 will mark the end of the five (5) year LOSST contributions. With the anticipated revenue of \$900,000 for the final year, we plan to continue to make improvements throughout the City, which may include street improvements, trail extensions, EKG monitors and defibrillators for the police and fire departments, park improvements, and maintenance to the water towers #1 and #2.

LOSST dollars were used in many other areas around the City. Where possible, we have put up signs showing the projects that were funded with LOSST dollars. You may have noticed these around Hiawatha in the parks or along the roadway. With the addition of LOSST as a source of revenue, the City has been able to do some of these improvements that may have otherwise been delayed due to the lack of funding. So, thank you to our voters, we were able to do these projects, along with others we are planning for the future to make your City the best it can be.
