### North Center Point Road/Emmons Street/Robins Road Intersection Update

The west side of North Center Point Road is now complete. The contractor has moved traffic to the newly constructed west two lanes, which allows the removal of the east one-half of the street. The remainder of the intersection will be completed next and Emmons Street and Robins Road will be reopened using the new intersection and traffic signals. The last phase will be the reconstruction of Robins Road to the north. Plan for traffic delays during this phase and please proceed with caution as a considerable amount of construction equipment is working in the area.

The work includes a new traffic signal, new street lights, new bike trail and landscaping.



### **Tower Terrace Interchange**

On June 13, 2017 the Iowa Department of Transportation Commission approved the Fiscal Year 2018-2022 Transportation Improvement Program. The program reflects Iowa's investment in the multimodal transportation system to provide safe and efficient mobility. The new standard diamond interchange proposed at I-380 and Tower Terrace Road is included in the 2022. The program is posted on the Iowa DOT website.

# Look for the Hiawatha I.D. Badge before Doing Business with Solicitors and Peddlers

They may be driving an ice cream van up and down the residential streets selling frozen treats, parked in City right-of-way selling food out of a pushcart, or going door to door selling their goods and services. Individuals carrying out any of these types of activities are known solicitors/peddlers or "vendors." To confirm the vendors are registered and licensed to conduct business in our City, residents should look for an identification badge issued by the City of Hiawatha.

If the vendor is not wearing the identification badge in plain sight, ask them to present the badge which will have the Hiawatha logo printed on it, along with the individual's name, company name and license expiration date.

### **Duty Crew Change and New Officers**

Did you know the fire department is made up of both paid and volunteer personnel? The current roster is made up of four full time, 4 part time and 45 volunteer firefighters, EMT's and Paramedics. The paid staff primarily work Monday through Friday from 7 AM to 5 PM. They serve triple duty by providing coverage during the day, when there are fewer volunteers. They staff the ambulances, the first responding fire engine and do administrative work to keep the fire department and ambulance service operating. The volunteer

members provide almost all the coverage after 5 PM and on weekends. Recently, the volunteer members switched from a five crew system to a six crew system. Crews are now on duty every sixth day. Along with that, six new duty crew officers were appointed or reappointed to oversee the operation of the crews. The Duty Crews are made up of six to eight responders who provide the initial response to medical and fire calls, backed up by off duty staff. Because the Duty Crews play such an important role in providing services, it's important to have strong leaders in charge of each crew. On June 7, City Council approved the appointment or reappointment of the following individuals:

Rob Archibald was promoted to Captain. Member of the fire department since 2002. Matt Lellig was promoted to Lieutenant. Member of the fire department since 2007. Chris Liscum was promoted to Lieutenant. Member of the fire department since 2013. Brad Ransford was reappointed to Captain. Member of the fire department since 2005. Scott Studt was promoted to Captain. Member of the fire department since 1998. Andrew Sweeney was promoted to Captain. Member of the fire department since 2003.

Together, these gentlemen bring 74 years of experience, along with countless hours of training, leadership and life experiences and a variety of backgrounds. We have met individually and discussed expectations and they are each very excited to move forward with the new crew system.

### **Unified Development Code (UDC) Review Committee Update**

Recently the City of Hiawatha updated its Comprehensive Plan. Our new plan is a vision of Hiawatha's development over the next 20 years. It includes a description of our goals and a road map to achieve those goals. Comp Plan 2036 includes the specific values Hiawatha choose to uphold and a description of our role in the Northeast Iowa Corridor.

The plan includes a set of projects for maintaining a path to progression. One of the first items is to review our current codes and ordinances assuring alignment with the Comprehensive Plan. To that end, City Council, with recommendation from the Planning and Zoning Commission has approved the formation of a UDC review committee. The committee includes representation from local citizens, businesses, developers, P&Z Commission, Council and city staff.

The objectives of the Committee are to:

- · Simplify our UDC to assure consistent interpretations
- Modify the requirements to match present zoning policies
- Amend the UDC to align with the Comp Plan 2036 objectives
- Update the language and references to reflect new planning methods

Severe bleeding can be a life threatening emergency. In fact, someone can bleed to death in as little as 5 minutes. Severe bleeding can happen at home, work or play. It can happen from

everyday emergencies, natural disasters or man-made crisis including acts of violence. Fire Medic Shelby VanWeelden recently attended a train the trainer program called "Stop the Bleed." Stop the Bleed is a nationwide campaign sponsored by the Department of Homeland Security through the National Security Council, designed to empower lay people to act quickly when someone is bleeding. The purpose of the program is ultimately put bleeding control kits in public places, similar to where AED's are now and to provide training to lay people in how to use those kits. We know statistically that AED's, in the hands of trained lay persons, are saving lives. The hope is that the same can be accomplished with the "Stop the Bleed" program. 
