"Shred-It" Company of Cedar Rapids, Linn County Solid Waste Agency, Midwest Electronics Recovery, Hiawatha Legion Post #735, Hiawatha Lions Club and Hy-Vee TAKEAWAY assisted our community in it's disposal of paper, electronics, hazardous household waste, unserviceable flags, glasses, hearing aids and prescription waste.

Our Community saved approximately 5 trees; shredding 420 lbs. of paper, collected 14,680 lbs. of electronic equipment to be recycled, received ten unserviceable flags, 200 pairs of glasses and six hearing aids for donation, prescription waste and a total of 110 individuals participated in the Hazardous Household waste drop off by dispersing 1352 lbs. of chemicals.

L.O.S.S.T. Vote Update

As you are no doubt aware, official results show that the Cedar Rapids Metro block, the Unincorporated Area block and the City of Walford rejected their respected public measures by very small margins for the 20 year 1% Sales and Service Tax Extension. Hiawatha's results: Yes (457) No (479) with the Metro Area as a whole: Yes (15,855) No (16,076).

Thank You for voting, whether you voted "yes" or "no", we appreciate the time you invest in gathering information to make an informed decision as you step up to the voting booth.

You may be asking yourself, "Can a Local Option Sales & Service Tax (L.O.S.S.T.) Election be called for again?"

The answer is: Yes. If one or more jurisdictions in a county do not currently have the tax imposed or will not have the tax imposed at a point in the future, a Local Option Sales & Services Tax election can be called. The Code of lowa does not mandate certain wait-time between elections. Therefore, another election can be called immediately for any eligible special election date. As with this past election, the City of Cedar Rapids, with its population of over 50% of the county, is the only jurisdiction that can call for the election. A petition can also be filed calling for a Local Option Sales & Services Tax Election.

NIXLE Discontinuation

Effective immediately the City will no longer be using the NIXLE information system to notify citizens of such things as street closures and event reminders. The City will continue to provide our citizens with important information through our city website, newsletters and by press releases. Departments such as Fire, Library and Parks & Recreation will additionally use their Facebook page to share information regarding their department activities.

Severe Weather and Tornado Safety

Now that the worst of winter is behind us, it usually means the worst of spring is just ahead. The arrival of warmer weather also means the arrival of tornados. For those of us in lowa, tornado season occurs between March and October, and while there is little you can do to prevent damage from a tornado, you can save your life by knowing what to do!

Watch vs. Warning

A severe thunderstorm watch means that severe weather is possible. A severe thunderstorm warning means that severe weather is in the immediate area. In either case, listen to the radio or television for updates. A tornado watch means that present conditions could produce a tornado. A tornado warning means that a tornado has been sighted, and that you should seek shelter immediately.

The National Weather Service can alert the public to the potential of severe weather more efficiently than ever. Stay tuned to the radio or the Weather Channel for updates. If your neighborhood is threatened by a tornado, severe weather warning sirens will activate (these sirens are tested on the first Wednesday of every month at 9 a.m.).

Know where to go

If a tornado has been sighted, take cover in the safest place possible. A basement is always the first choice. Your options include:

- Building with a basement: Go to the basement. Stay away from windows and chimneys. Hide under the stairs or heavy furniture. Cover your head.
- <u>Building without a basement:</u> Go to the lowest level in the central portion of the building. The first choice is in an interior closet or hallway, away from windows. Cover your head. In all cases you should have a flashlight and a battery operated radio with you. Keep your keys with you they can disappear in a tornado.
- Shopping center or large building: Look for a pre-designated shelter. If you don't see one, go to the
 middle hallway on the lowest level. Cover your head.
- <u>Mobile home or car:</u> Leave at once and find shelter in a building. If there is no shelter nearby, lie flat in the nearest ditch, ravine, or culvert with your hands over your head.

Following these steps can minimize the possibility of death or injury during severe weather. Share these tips with your family, and practice a tornado drill in your home this week.



Hiawatha Firefighters Certified in Child Seat Safety


Congratulations to Fire Department Deputy Chiefs, Rob Archibald and Andrew Sweeney in acquiring their "Child Passenger Safety Technician" certification. The National Child Passenger Safety Board has been established to provide program direction and technical guidance to states, communities and organizations as a means to maintain a credible, standardized child passenger training and certification program.

The Standardized Child Passenger Safety (CPS) Training Program was established in 1998 in response to a need for standardization and quality control in course content and instruction.

Child passenger safety certification courses are designed to teach individuals the technical and educational skills needed to serve as child passenger safety resources for their organization, community or state.

Certification courses are conducted by a variety of local, state and national agencies and organizations, and those who successfully complete the certification courses are eligible to receive national certification as a Child Passenger Safety Technician through the Safe Kids Worldwide CPS certification program.

Rob and Andy will be able to assist our citizens with important injury prevention measures by providing a child safety seat check inspection.

Projects

Stamy Road Paving and Utility Improvements

The Stamy Road reconstruction project will replace 1300 feet of gravel and sealcoat street with a concrete curb and gutter street from the existing paved end of Stamy Road to Tower Terrace Road. The project also includes water main, storm sewer and sanitary sewer extensions. The City received a \$351,000 Revitalize lowa's Sound Economy (RISE) grant from the state for this project. Construction is expected in late Summer or early Fall of 2011.

Industrial Drive Pavement Reconstruction

The Industrial Drive reconstruction project will replace 1300 feet of concrete street which is beyond its service life. The new concrete pavement will be similar to what is used on major streets to support heavy truck traffic. Drain tile and/or storm sewer will also be provided. Construction is anticipated in Fall 2011.

2011 Sanitary Sewer Repairs

This project will repair sanitary sewer pipes that are cracked or have leaky joints. It is part of an ongoing annual effort to reduce groundwater inflow and infiltration to the sanitary sewer, with the goal of reducing wastewater treatment costs. Construction is expected in Summer or Fall 2011.

North Center Point Road from Stamy Road to Tower Terrace Road Pavement Reconstruction

The project is now under construction with the road closed between Ketelsen Drive and Tower Terrace Road. A signed detour route is in place for traveling between Tower Terrace Road and Boyson Road. Ketelsen Drive continues to be accessible by North Center Point Road.

The amount of flouride added to our drinking water was reduced from 1.0 to 0.7 part per million. Flouride is a naturally occurring mineral that is proven to protect against tooth decay by keeping tooth enamel strong and solid. Police Department Summer Safety Reminders

Please watch for children who are riding bicycles or walking near the roadway. Be prepared to stop as children are not always watching for you. It is also a good time to revisit safety tips with each of your children.

- Never play in the street
- Always wear your safety helmet when riding a bike or skateboard
- Make sure your parents know where you are and when you will return
- Never talk to strangers; report any attempts by a stranger to an adult

Curfew Reminder - A curfew is in effect for anyone under the age of 16. Persons under 16 years of age are not permitted to be or remain upon any alley, street, or public places between the hours of 11:00 p.m. and 5:00 a.m. unless accompanied by a guardian, parent or other person charged with the care and custody who is over 18 years of age. The curfew does not apply to a minor traveling between his or her home or place of residence and the place where any approved employment, church, municipal or school function is being held.

Also, please be considerate of your neighbors if you own a dog. Do not let your dog(s) run at large. Each owner is responsible to ensure their dog(s) do not bark or howl excessively causing neighbors to be unduly disturbed.

Police Department Fireworks Safety

It is that time of year when fireworks become popular for a few weeks surrounding the 4th of July. Here are a few important safety reminders from the Consumer Product Safety Commission.

- Never point or throw fireworks at another person.
- Keep a bucket of water or a garden hose handy in case of fire or other mishap.
- After fireworks fully complete their functioning, douse the spent device with plenty of water from a bucket or hose before discarding to prevent a trash fire.

Adults should always supervise fireworks activities. Parents often don't realize that there are many injuries from sparklers to children under five. Sparklers burn at temperatures of about 2,000 degrees - hot enough to melt some metals. Your safety is important to us, by following these simple guidelines, you can ensure your safety and the safety of others.
