

The COVID-19 pandemic has certainly consumed much of our time and will continue to be as the numbers of coronavirus cases in the U.S. is now approximately 1.9 million and the death toll is over 107,000. In our continued efforts to protect our city staff and our citizens city staff have worked through a Phase I and Phase II Reopening Plan. These plans are subject to change if Linn County numbers increase vs. decrease.



- 90% of staff are on site
- Public Access limited access by appointment only
- Essential meetings only; boards, commission and council meetings when in session will follow the
  mass gathering criteria which includes limited capacity, social distancing, practice best hygiene and
  public health measures as prescribed by Iowa Department of Public Health. Virtual meetings will
  continue.
- Encourage citizens to continue to utilize online services and the drop box in front of city hall for utility bill and permitting payments
- Staff is preparing for limited and reduced public occupancy placing personal protective equipment such as sneeze guards at counters, signage and floor markings placed to encourage social distancing
- Masks will be required as you enter city hall. Hand sanitizing and mask stations will be available to citizens at the entrance of city hall
- Community Center rentals continue to remain closed through July 13
- Library Curbside pickup available M-Th 10AM-7:30PM; F-S 10AM-4:30PM. Closed on Sunday
- Library Phone Service available M-Th 10AM-8:00PM; F-S 10AM-5PM. Closed on Sunday
- Library book drop is open







Two people wearing masks




#### BETTER

#### **Hiawatha Police Department COVID-19 Response**

For nearly three months now beginning on March 15th, the Hiawatha Police Department (HPD) has taken thoughtful steps to ensure the safety of its employees in order to maintain the level of service expected of us. COVID-19 brought unprecedented concerns into the community and workplace, and in order to continue the level of service we deliver to the community a number of precautions were implemented. The HPD offered exposure reducing guidance and equipment based on recommendations and findings from the CDC, Linn County EMA, Hiawatha Fire Department, and medical director Dr. Timothy Sagers.

With one of the first known warning signs of COVID-19 illness being fever, we began by requiring employees to report to the Hiawatha Fire Department for fever screening at the beginning of every shift. This continued until we were able to obtain a, suddenly in short supply, non-touch thermometer of our own. We secured our own thermometer in an effort to avoid potential exposure from other first responders at the HFD.

We then began with requirements for wearing a face mask, and eventually added goggles as well. Masks were initially provided by Linn County EMA followed by departmental purchases and generous donations from a number of sources. We implemented increased hand washing procedures and hung signage as a reminder to wash upon every entry to the HPD. We also increased sanitizing efforts at work stations and in squad cars. The HPD purchased hand sanitizer from Cedar Ridge Winery/Distillery, in addition to purchasing items needed to make our own sanitizing wipes in anticipation that our supply of Clorox wipes may run out. The department purchased an air purifier that utilizes ultraviolet light to destroy airborne viruses. We used this air purifier in the police department in addition to using PPE and other sanitizing efforts.

Finally, the HPD modified the work schedule for normal operations. We limited the rotation of shifts so that potential exposure on one shift would not lead to exposure on another, in addition to limiting contact at shift change and observing social distancing recommendations when possible.

#### Hiawatha Parks Become Trash-Free June 1

Trash-Free Parks began June 1. This is an opportunity for us not only to help with the spread of germs, but for the safety of our staff and users too. It will be an educational piece, as this comes with any change, but we hope park users will continue to take pride in our City parks as we do. Like State Parks, we are simply asking for users to take home what they brought in.


#### Fireworks and Summer Safety Tips

Public Safety Officials from the City of Hiawatha want to remind you that the display and use of consumer fireworks are allowed in Hiawatha, on a very limited basis during the times below. This does not include the display of commercial fireworks. It is important to remember that fireworks may only be used by someone age 18 or older, on their own property, or the property of someone that has consented to use. Do not assume you have permission. Fireworks cannot be used on streets,roads, or other public right-of-ways. That also means the use of fireworks is forbidden in all city parks without a permit. It is your responsibility to know what you are doing and what you are using is legal. The fine for violating any of these laws will be \$250. If you cause an injury, fire, or damage to property, you may be charged with additional crimes. The display of consumer fireworks is allowed only during the following designated times:

- July 4th 12:00 PM. to 11:00 PM
- December 31st 6:00 PM to 12:30 AM on January 1

Here are a few summer safety tips to go along:





- Build campfires at least 15 feet away from buildings, shrubs or other materials that burn.
- Fireworks must only be used with proper adult supervision and never shoot fireworks while intoxicated or impaired. Always expect the firework to do something unexpected.
- When lighting fireworks or having a campfire, keep a garden hose or fire extinguisher nearby in case of problems.
- Keep a bucket of water to put wire sparklers in. Sparklers account for nearly 1/4 of all fireworks injuries. Sparklers can burn at 1,200 degrees, can cause 3rd degree burns in a fraction of a second and improperly discarded sparklers can cause fires.
- DO NOT AIM bottle rockets, roman candles and other fireworks toward people, buildings, vehicles or others property. Keep a distance of 20 feet from buildings or people when lighting fireworks.

We are set up in our parking lot with a table and totes displaying appointment times. If the outside staff member is helping another patron, you may take your items from the appropriate tote. Your materials will be bagged and have a hold tag attached with the first three letters of your last name, and the last four digits of your card number. All items will have already been checked out on your account.

Though we are not able to let patrons in the building just yet we're happy to print, copy, and fax for you. Email any prints to library@hiawatha-iowa.com. You can call to set up a time to pick these up as well. For copies and faxes, please bring your materials to the library, and we will provide the service and return them to you outside the library.
