The proposed location of the Tower Terrace Interchange took another step forward in recent weeks. Although our planned trip to Washington, D.C., was cancelled due to the tremendous snowfall on the East Coast, our requests for funding have not gone unheard by Washington officials.

Different from prior years, the Cities of Hiawatha, Robins and Marion are working together to 319-393-1515 X 523 promote the Tower Terrace Corridor. In the past, all jurisdictions have worked independently for development of a roadway or preservation of right-of-way.

> This year our short presentation was made by conference call, with Lon Pluckhahn, Marion City Manager, being the primary spokesperson for all our jurisdictions.

Further evidence of all jurisdictions working for a common interest objective is the passage of a support resolution for the Tower Terrace Corridor, including the interchange, by the City of Cedar Rapids City Council in February 2010.

Officials from Marion, Robins, and Hiawatha will be meeting soon to provide Washington, D.C., staff with additional requested information regarding the Corridor project.

# Wellhead Protection Program

Hiawatha Water Department is in the process of establishing a new program that will help protect our water supply. There is only a thin, confining layer of soil over the Silurian Aquifer, which is where the City's water is drawn from, therefore, it can leave our water supply susceptible to contaminates. Our Wellhead Protection Program will have the proper restrictions that protect the City's water supply and well fields.

It will also prohibit the location of potential contamination sources close to our public water supply. The lowa Department of Natural Resources has recommended that the City develop a Wellhead Protection Ordinance, not only for the above reasons, but also to promote public health, safety and the general welfare of our residents.



# Emergency Vehicle Law and How It Pertains To You.

Move over or slow down for emergency vehicles. It's not just a courtesy; it's the law in lowa and many other states. Breaking the law can result in fines or jail time if an accident occurs. lowa has two laws that pertain to this. One involves emergency vehicles with flashing lights that are stopped on the side of the road. These vehicles include police cars, fire department vehicles, tow trucks, utility maintenance vehicles, and road maintenance vehicles. By law a vehicle approaching a stationary emergency vehicle with flashing lights is required to safely change lanes if possible. If it is not possible to change lanes, then safely reduce your speed to below the posted speed limit and proceed cautiously. Be aware of people exiting and entering stopped emergency vehicles.

The second lowa law deals with emergency vehicles with flashing red or blue lights, audible sirens or bells that are approaching you. These vehicles include fire, police, and state patrol cars. The law states that when you are approached by emergency vehicles with flashing lights and/or audible signals, you are to safely pull over to the right hand side of the road and stop. If you are stopped at an intersection and can't pull over, just stop and stay where you are and let the emergency vehicle maneuver around you. This applies whether the emergency vehicle is approaching you from the front or behind.

These laws are designed for your safety and the safety of officers, firemen, emergency personal, maintenance personal, and road construction workers. Remember, slow down, move over - it's about safety! # Street Beautification & Right-of-Way

The transportation system has always been a foundation of community design. Perhaps more now than in years past, we are viewing the aesthetic value of arterial streets for economic development purposes.

The City has a substantial investment in our arterial streets and more specific, it's right-of-way. Developing Center Point and North Center Point Road, the artery of our community, caused the City to look at several factors as part of the decision making process when planning street beautification efforts. We considered the alternative forms of transportation: paving, seating, planters, trash cans and lighting, creating character along our street ways.

The positive impacts of our pedestrian friendly streetscape are the improvements that help make our community healthier, more vibrant and a more attractive place to live, work and own a business. For our citizens, pedestrian friendly streets encourage people to walk and bike rather than drive. For employers, it is not just about the bottom line, quality of life in a prospective community is an important factor as well. When it comes to beautification of the arterial streets, we must put our best foot forward to show citizens, business owners and people passing through we are a friendly, progressive community.

In an effort to maintain the beauty of the City's corridor and to keep our public right-of-way clear of any eyesores or nuisances, our City has established an "Adopt a Flower Bed Program" and allows planting of trees, shrubs, grasses or flowers while still protecting the integrity and safety of our streetscape beautification and to the traveling public.

City Code of Ordinances, Chapter 134 Right-Of-Way, regulates the use of public right-of-way in the interest of public safety, convenience and the operation and protection of public works infrastructure.
