### Hiawatha Economic Development Corporation

Most of you have probably heard of the phrase "Cedar Rapids/Iowa City Corridor" being used when people talk or write about economic development projects. While the regional promotional organizations insist this phrase includes most of Linn County, in reality their focus is on 319-393-6601 projects so large as to exclude the cities surrounding Cedar Rapids. This is so consistent that we have believed for a long time that the "Corridor" starts at Blairs Ferry Road and continues south. When I spoke with other cities, community leaders and your City Council, it was very apparent that I wasn't the only one with this feeling. It just doesn't seem like Hiawatha was 319-393-1515 X 232 included in the overall business economic development loop within the Cedar Rapids Metro area. Areas north of Blairs Ferry Road do not appear to be a part of the corridor.

In December 2009, a group of Hiawatha business leaders met at City Hall to discuss what 319-393-1515 X 133 steps could be taken to generate commercial growth within our City. One of the ideas deriving from this meeting was. Hiawatha could do a better job of marketing ourselves. We have the talent and resources within our City to sell Hiawatha better than any outside group. We may not have all the answers but we have a good idea where to get them.

On April 14, 2010, the group met again and unofficially became "Hiawatha Economic Development Corporation (HEDCO)". The group would like to form an economic development corporation much like Marion's "MEDCO". It may even be appropriate to partner with "Medco" in 319-393-1414 attracting new business opportunities to Hiawatha. Economic Development is important to our City because commercial growth is a true driver in stabilizing our tax base.

> As with most groups, we will take small steps, establish a plan of action and move forward one step at a time with specific goals in mind. This is a bold new direction for our City, setting our mark high, knowing this idea will open a whole new world of opportunities for your community and its future growth.

### Hiawatha Budget Update 2010

Your Hiawatha elected officials have once again approved to keep your tax rate the same as last year. The rate will remain at 15.31% per \$1,000 of property valuation. Due to the increase of the state mandated roll-back factor, the property owner of a home valued at \$100,000 will pay \$718.21 in taxes to the City of Hiawatha in the next fiscal year, beginning July 1, 2010. Residential homeowners will pay tax on 46.9 percent of the value of their home in the new budget, up from the current 45.56 percent of the value.

Hiawatha's tax valuation grew by 12.18% due to the new residential, commercial and industrial construction in the community. The quality businesses that have located in Hiawatha continue to be a great asset to our community. As a result of the balance of residential, commercial and industrial growth, we have a balanced tax base for the City of Hiawatha.

Hiawatha has been able to keep our tax rates reasonably low and stable, due to the diligent efforts of your Mayor and Council Members on economic development and fiscal matters. With their continued efforts, Hiawatha will continue to provide taxpayers the best cost-of-living value in the area.

### Hiawatha Police Department Updates

K-9 Unit Update

In 2005, the Hiawatha Police Department received funding for our K-9 program through a K-9 Grant. At that time, Officer Melsa was selected as the K-9 handler. Our K-9 is a male, pure bred German Shephard named Mod. Training of the K-9 handler and Mod took place in Michigan over a six week period. Mod is originally from the Czech Republic and knows his commands

in the Czech language. Mod is a dual purpose K-9, trained in Narcotic Interdiction, Tracking, Building Searches, and Criminal Apprehension. Mod has proven to be a valuable asset in all of these areas. Officer Melsa and Mod work together on a daily basis and are on call 24/7. Mod and his handler have participated in many public events, including visits to various schools and libraries in the Linn County area. Mod is scheduled to appear at the Hiawatha Public Library on Monday, June 14, 2010 at 1:00 p.m.

We have one vehicle in our fleet dedicated to the K-9 program. The last vehicle, a 2004 Ford Crown Victoria, was replaced with a 2010 Chevrolet Tahoe in April. With the switch in vehicles, we gained much needed space for gear and added the ability to transport arrested persons to jail without utilizing an additional squad vehicle.

Governor's Traffic Safety Bureau Update

One component of our overall commitment to reducing traffic accidents while increasing seatbelt usage is to conduct periodic seatbelt surveys. The surveys are conducted by an officer stationed at a specific location for a set period of time. All occupants are observed to determine compliance with the law. During our two (2) most recent surveys, the compliance rates were 93% and 95% respectively. These are very encouraging results and undoubtedly help in reducing possible injuries should you be involved in an accident.





### Hiawatha Water Department News

#### Wellhead Protection Program

Hiawatha Water Department is in the process of developing a Wellhead Protection Ordinance to protect our water supply system. This program is being put into place due to our community's unconsolidated confining layer of soil over the Silurian Aquifer, which is where the City's water is drawn from, therefore it can leave our water supply susceptible to contaminates.

The Wellhead Protection Program will have restrictions that protect the City's water supply and well fields. It will also restrict the location of potential contamination sources close to our public water supply. The ordinance sets up three (3) protection zones around each municipal well site of a 200 foot radius, 1000 foot radius and/or 2,500 foot radius. The lowa Department of Natural Resources has recommended the City develop a Wellhead Protection Ordinance to help control hazardous material that are used, stored and manufactured within our community.

This ordinance also has an existing uses section that states the following:

"The use of structures or facilities existing at the time of adoption of the ordinance codified in this chapter may be continued even though such use may not conform with this regulations of this chapter. However, such structure of facility may not be enlarged, extended, reconstructed or substituted subsequent to adoption of said ordinance unless an exemption is granted by the City Council."

#### **Backflow Prevention Devices**

Reminder to Hiawatha Residents: If you have an RPZ valve (backflow prevention device) on your water line, please remember that this needs to be tested yearly (preferably in the spring) by a registered technician per City Ordinance. Inspection forms may be picked up at the City Hall or your registered technician should have similar forms. Call the Water Department at 393-5556 with any questions or comments.

### Community Development News to You

Spring is on its way!

Spring is here. The spring showers will be a welcome change from all of the snow and ice. When it rains, the storm waters end up back in our water sources. These storm drains lead to lakes, streams, and rivers. Storm water transports pollutants into our drinking and recreational bodies of water. So please help protect our water quality by following a few simple rules.

- Grass and weeds should be kept at 8" or less. The recommended grass length is 3". When your lawn is 3" tall, it allows water more time to absorb into the soil versus running into the street or onto the sidewalk and towards the storm drains.
- Grass clippings should never go into the street. This clogs storm drains and affects the quality of our water.
- Direct downspouts away from paved surfaces. All drainage needs to be dispersed on your own property.

One unique option that has been catching on throughout the United States is to divert your downspouts to rain barrels. Rain
water from roof water run off is collected in rain barrels and then can be used to water your yard, flowers or garden. It has been

estimated that a 1/4 inch of rainfall on the average roof will amount to about 50 gallons of clean natural water. They have rain barrels available for purchase at a reasonable cost to help reduce and redirect water away from streams and rivers. Their website also has additional information for reducing floods.
