#### **Budget Overview**

July 1, 2017 marks the beginning of a new fiscal year for the City of Hiawatha. The city's finances are divided into six categories/funds, which include, General Fund, Special Revenue Fund, Tax-Increment Financing (TIF) Fund, Debt Service Fund, Capital Project Fund and Enterprise Fund.

The General Fund is the chief operating fund of the city. It supports operations including Police, Fire, Ambulance, Library, Park and Recreation, Building, Mayor and Council, Administration and Finance, City Hall, Legal Fees and Election expenses.

The Special Revenues Fund contains the proceeds from a specific source which are required by law to be accounted for separately and used for specific purpose. Included in the Special Revenue Fund are TIF revenues, Road Use Tax, Local Option Sales Tax and Employee Benefits.

The TIF or Tax Increment Financing Fund is a special revenue fund that allows the city to achieve a variety of economic development goals, including job creation, growth in property values and protection of the local tax base. TIF can also be used to finance public improvements (such as streets, water, sidewalks, and other infrastructure).

The Debt Services Fund is dedicated for the payment of principal and interest on the city's long term debt. This is a special levy that the council approved in the budget to pay for our debt payments in FY18.

Capital Projects Fund is used to account for the resources used in the acquisition and construction of large capital projects including but not limited to street construction, water and sewer main extensions or repairs, land, equipment or building acquisitions and storm water installations or repairs.

The Enterprise Fund consists of the operations and maintenance of the city's utilities including water, sewer and storm water.


Illustrated in the chart below is the budget expenses by fund for the upcoming budget year of July 1, 2017 to June 30, 2018. As you can see the Capital Project Fund is the largest portion of the city's budget, 37% of the total budgeted expenses equaling \$9,473,000. General Fund is the second largest at 18% or \$4,590,596. Special Revenue is next at 15% or \$3,819,093. Debt Service is at 13% or \$3,259,040, this includes the payments made for all of the city's debt. Enterprise Fund expenses are \$2,264,675 and are 9% of the total. TIF expenses at \$2,014,952 or 8% of the budget, TIF expenses include payments of principal and interest on the city's debt and the Development Agreements that are in place to aid in economic development. The total operating budget for the city in the upcoming fiscal year is \$25,421,356.

At the March 1, 2017 regular council meeting, the City of Hiawatha City Council adopted the budget for the upcoming Fiscal Year 2018 which begins July 1. Discussions began last fall with department managers and council members, by setting priorities and goals for the coming year.

The City of Hiawatha elected officials have weighed the needs and benefits of projects and services against their associated costs. Some of the projects included in the FY18 budget are Water, Sewer and Storm Water improvements, updates in the Park and Recreation Department, Library, Fire and Ambulance Service and the Police Department.

Taking into consideration of the council's goal to maintain the tax levy rate, they were able to levy for the Liability Insurance, Employee Benefits and Debt Service while considering the rate.

The tax rate remains the same as last year's rate of \$15.41 per \$1,000 of assessed taxable valuation for Fiscal Year 2018. Based on a property valued at \$100,000, the city portion of your property taxes would be approximately \$877.53. The city's tax levy is a very important part of the residential property-tax equation. A property owners' tax bill is determined when Linn County Assessor values a property and the state sets a "rollback", of what percentage of the value of property is subject to tax. The property value is then multiplied by the levies of the other jurisdictions with taxing authorities, such as the State of Iowa, Linn County, Local School Districts and Community Colleges.



#### **Mosquito Control Program 2017**

On April 5, City Council awarded the 2017 Mosquito Control Program to Mosquito Control of Iowa from Rolfe, Iowa. Mosquito Control of Iowa has over 30 years of experience in the industry and they have been performing mosquito spraying services in Hiawatha for the last several years in a row.

Hiawatha uses a Full Integrated Pest Management Program including a combination of treatments throughout the season based on the NEPDES permit. Program services include surveying, monitoring, larvaciding in stagnant water areas to control mosquitoes in the larva stage and contact and residual spraying. Depending on the weather and species of mosquitoes encountered, the treatments will be selected from the control methods to provide the city with the best results. Mosquito Control does all spraying by ground using multiple pieces of equipment; they do have an airplane but it is used only for emergency situations.

#### **Another Good Neighbor Policy: Lawn Care**

As warmer weather and seasonal rain approaches the Hiawatha Community Development Department would like to remind our residents of our good neighbor policy regarding tall grass and weeds.

The Hiawatha City Code of Ordinances Section 50.02(10) requires property owners to keep grasses mowed so that grass and weeds are less than eight inches in height. This includes the individual lot, along with parking adjacent thereto, alleys, public ways or areas up to the centerline of said ways.

By maintaining the grass and weeds to the required height it will help eliminate certain health and safety concerns. An additional benefit to proper lawn maintenance is the enhancement of our storm water management.

Spring is almost here. The spring showers will be a welcome change from all of this snow and ice. When it rains, the storm waters end up back in our water sources. The storm drain leads to lakes, streams, and rivers.

Storm water transports pollutants into our drinking and recreational bodies of water. So please help protect our water quality by following a few simple rules.

- Grass and weeds should be kept at 8" or less. The recommended grass length is 3". When your lawn is 3" tall, it allows water more time to absorb into the soil versus running into the street or onto the sidewalk and towards the storm drains.
- Grass clippings should never go into the street. This clogs storm drains and affects the quality of our water.
- Direct downspouts away from paved surfaces. All drainage needs to be dispersed on your own property. This helps to prevent pollutants such as motor oil or detergent from entering our water sources.

#### **Breakfast of Champions**

City Administrator Kim Downs was a presentation speaker at the Breakfast of Champions monthly meeting. Breakfast of Champions was formed in 2009 as a group of professionals that want to grow their business and professional networks in a fun environment while giving back through community service. Downs spoke of economic growth, Town Center concepts and Tower Terrace and Boyson Road Interchanges.

Downs shared the City of Hiawatha'a vision for growth and how the city effectively conducts business. Hiawatha has been focusing on business growth and retention most recently through our Hiawatha Business Success stories by working as a partner and taking pride in our business community successes. Hiawatha's population in 2010 grew by 8% with 2020 projections to reach 12%. Permit fees in 2015 increased by 70% with 2016's mirroring 2015.

Hiawatha has room to grow and is not land locked. Currently with 671 acres of developed ready land and 139 acres as shovel ready, Hiawatha will continue to see economic growth both residentially and commercially. Water and sewer infrastructure is readily available to all areas within the city's boundary limits. There was much discussion on the need for a Tower Terrace Interchange and it's relief to Boyson Road traffic. The Tower Terrace Road Interchange is history in the making with our metro communities working together to ensure it's success through the Iowa Department of Transportation five year planning process with a projected construction date of 2022.

The City of Hiawatha intends to apply for a 2018 Housing Fund grant through the Iowa Economic Development Authority (IEDA). If successful, grant funds will be available to assist homeowners in the City of Hiawatha with the rehabilitation of their homes.

City awarded financial assistance will be available in five-year terms. Participants will not have to make any repayments of the forgivable loan unless the home does not remain as the home owners principal residence for the entirety of the five-year term.

Before we can apply, the city will need to conduct a low and moderate income (LMI) survey to meet the national objective of primarily benefiting low and moderate income (LMI) persons. This means that at a minimum, 51% of those benefiting from the activity must be considered LMI, and applicants must be able to document the benefit to determine the city's eligibility.

The city will conduct a survey format called a house to house survey. Shortly, the city will distribute surveys by mail to each household in the project area. The designated project area for 2018 will be along west Clark Street to Blairs Ferry Road and east of the interstate. Following the mail distribution individuals can return the completed survey back to the city. All information received will remain anonymous. If the city does not receive a 95% confidence level through mailing city staff and volunteers will than need to complete a door-to-door survey. A confidence level provides a range of values which contains the population parameter of interest to determine if the city has enough residential interest in applying for the housing rehabilitation grant. The survey is a simple form asking only two questions: total number in the household and the level of household income above or below the dollar figure shown on the survey along with name, address and value of possible repairs.

#### **Emmons Street/Robins Road/North Center Point Road Intersection Reconstruction Project Progress**

The third, fourth and fifth phases of the Emmons/Robins/North Center Point Road intersection reconstruction project are almost complete.
