# Tower Terrace Interchange and IDOT

On October 11, 2016 our metro communities; Hiawatha, Robins, Marion, Cedar Rapids and Linn County presented to the Iowa Department of Transportation (IDOT) Commissioners in Dubuque the need for a third interchange along I-380 at Tower Terrace Road Bridge. Many of you have either read or heard us talk about our efforts to construct a Tower Terrace Interchange as another route to I-380 and relieving the Boyson Road traffic. This interchange is a priority to our communities due to safety concerns: cars lining up on the interstate creating confusion and the potential for accidents. Our daily numbers of 19,300 cars traveling through the Boyson Road Interchange are nearing the Interchange Justification Report of 2040 projections of 24,000.



As local officials we requested the IDOT Commission add the \$20 million interchange project to their state plan in fiscal years 2020 and 2021. Our local groups have pledged \$5 million - \$4 million as a grant from the Corridor Metropolitan Planning Organization and \$1 million from local communities - toward the proposed diamond interchange. As city engineer John Bender said, "No one is sitting on their hands in this metro area, we're all working together to get this constructed and it all comes back to the interchange at Tower Terrace. We're all planning on that interchange being built."

City administrator Kim Downs provided the IDOT several letters of support for the project representing each of the communities, economic development groups and several local businesses. The local IDOT staff have received and placed the documents on file while they agree with our perspective on the need for the Tower Terrace Interchange. Jim Schnoebelen of the IDOT and IDOT staff agreed with the benefits and value of the project and stated the project will be considered, along with other projects during the development of the FY 2018-2022 Transportation Improvement Program. The Iowa Department of Transportation Commission, of course, will make the final decision on funding. In a follow up with Mr. Schnoebelen, he shared the IDOT staff will be preparing estimates and scenarios in December/January. They will begin briefing the Commission in February. He mentioned the programming will be set and presented in May with official IDOT commission approval in June. He thought by March we will know where we are sitting. As a reminder, this year the IDOT has the largest ever construction program by far, to go to letting in April so that may keep things a bit more up in the air than usual.

### Interstate 380 Improvements Open House Held October 12, 2016

The Iowa Department of Transportation held a public information meeting October 12, 2016 in Hiawatha City Hall. The purpose of the meeting was to discuss the proposed widening improvements to I-380 from Iowa 100 to County Home Road, **including a new proposed interchange at Tower Terrace Road and reconstruction of the Boyson Road Interchange.** The purpose of this study is to accommodate increased travel demands in the I-380 corridor.

The study area of I-380 is approximately five miles in length which is currently a 4-lane dedicated highway within the city limits of Cedar Rapids and Hiawatha. The IDOT has worked with local agencies on a feasibility study to evaluate potential solutions for corridor improvements that are

expected to:

- Accommodate future growth of traffic
- Improve traffic operations at ramps on I-380
- Address geometric deficiencies
- Support planned economic development and land uses

Over 100 interested residents attended the meeting and were able to share their ideas concerning the proposed improvements. Other opportunities for input will be provided throughout the project development process.

### North Center Point Road/Emmons Street/Robins Road Intersection Improvement Phase I and Phase II

The first phase of the North Center Point/Emmons Street/Robins Road Intersection project is now complete and all streets have been reopened to traffic. The new extension of "A" Avenue north of Clark Street is also complete and open to traffic which provides another access to Oak Street. The overhead electrical lines are in the process of being lowered to new underground utility conduits. This work is under contract with Alliant Energy along with other utility companies and should be completed in a few weeks.

The second phase contract awarded to Rathje Construction Inc. is under construction from Fisher Street to approximately 300 feet south. This work will be completed late fall which is a part of the first phase of the total project that will move the existing North Center Point Road/Emmons Street/ Robins Road Intersection approximately 100 feet northwest. Drivers should plan for changing traffic conditions which will include lane closures and lane changes. Two-way traffic will always be maintained on North Center Point Road. All lanes will be opened to traffic for the winter construction shut down.



Project completion date is November 2017.

#### Water and Sewer Extension Project Complete to Newly Annexed Area

The construction of sewer and water main extension to the newly annexed area along Edgewood Road between Fitzroy Road and County Home Road is now complete. Over 5,000 feet of 12" water main, 2,700 feet of 8" sanitary sewer and 4,000 feet of 8" pressure line has been constructed. This will now open approximately 300 acres to future development.



## **Boyson Road Trail Extension Project Under Construction**

The construction project for the extension of the Boyson Road Multi-Use Trail from 12th Avenue to 15th Avenue has now started. The proposed extension is the next project in the continued effort to develop a trail system along the south side of Boyson Road from Edgewood Road to the Cedar Valley Nature Trail east of North Center Point Road.

This project should be completed by mid November.

# **Linn County Minimum Wage Ordinance**

In September, Linn County Supervisors enacted a minimum wage ordinance establishing a minimum hourly wage applicable to certain employees and employers in the Linn County geographical boundaries. Linn County Minimum Wage Ordinance #4-9-2016 Wage Requirements established the hourly wage to be at least \$8.25 as of January 1, 2017; at least \$9.25 as of January 1, 2018 and at least \$10.25 as of January 1, 2019.

On October 5, the Hiawatha City Council passed Resolution #16-195 receiving and filing Linn County Minimum Wage Ordinance #4-9-2016 supporting Linn County's efforts to provide a working wage in all of Linn County. The City Council succumbed to Linn County's minimum wage ordinance with an increased hourly rate of \$8.25 to be effective January 1, 2017 to provide consistency throughout the Linn County boundaries and will review each additional annual wage

increase thereafter on its own merit.

The Hiawatha City Council also urged our Iowa General Assembly to consider passing a minimum wage bill - increasing a fair and consistent Iowa's minimum wage as a whole; in turn providing consistency throughout all of Iowa and encouraging a culture of work and a level playing field for the rising generation.

# Hiawatha Volunteer Firefighters

This month we recognize Jeff Daley as volunteer member of the month. Jeff joined the fire department in September 2006, as an EMS only member. As an EMS (Emergency Medical Services) only member, Jeff performs all the duties as an Advanced EMT, working on the ambulance. In addition, he also supports the firefighters at the scene of a fire or other emergencies. Jeff completed his EMT class about the time he joined. In 2015, he completed his Advanced EMT, which allows him to do certain skills beyond that of an EMT, but not quite at the Paramedic level. Since Jeff joined the fire department, he has responded to over 3,000 calls for service, the most for any volunteer member currently on record.



Jeff has also been active as the committee chair and co-chair for the fire department's annual "Fill the Boot" campaign for MDA since 2012. Since 2012, the fire department has raised \$56,640 during Fill The Boot. The department collected \$15,920 during the 2016 drive alone! That makes Hiawatha the highest collecting volunteer department in the region and consistently ranked in the top three departments, including career departments.

When Jeff isn't busy volunteering for the ambulance service, he operates his own commercial insurance agency, Daley Insurance. He lives just outside of Hiawatha with his wife, Cathy and their two children, Olivia (16) and Ryan (14).

# **Another Good Neighbor Policy**

We are now entering the snow and ice season for northeast Iowa. This is a reminder our City believes in maintaining a safe environment for our citizens and visitors through a good neighbor policy of sidewalk maintenance.

City Ordinance Chapter 136 deals with the construction and maintenance of all sidewalks in Hiawatha. This section of the code describes who is responsible for maintaining sidewalks, the standards for maintenance and the process for assuring the sidewalks are maintained.

A property owner is responsible for maintaining the sidewalk adjacent to their property (Sect. 136.04). This responsibility includes the removal of snow and ice and the maintenance of the sidewalk itself. Code Section 136.02 defines the "Defective Sidewalk" issues which must be corrected:



### **Snow Ordinance Reminder**

Our snow ordinance will be in effect when the National Weather Service (NWS) predicts a snowfall in which three (3) or more inches of snow are expected. While the Snow Emergency is in effect, **there is no parking on any city street**. Vehicles found parked in violation of this ordinance will receive a \$25 parking ticket and/or be impounded. During overnight snow removal operations, vehicles found in violation on City streets will be towed. The Snow Emergency declaration will be sent to all the local media including but not limited to: KGAN (Channel 2), KCRG (Channel 9) and KWWL (Channel 7). The declaration will also be posted on the City website, www.hiawatha-iowa.com. Your cooperation is appreciated.

#### **REMEMBER - Don't park in the street if:**

- The 24 hour (or less) prediction by the NWS is for three (3) or more inches of snow.
- Three (3) or more inches of snow has fallen and/or your street has not been cleared.

When in doubt about parking, just move your vehicle off the street.

Also, the City will **NOT** generally conduct snowfall clearing operations on all streets for a snowfall of less than two (2) inches. This policy remains unchanged from prior years. Please remember: sidewalks must be shoveled within 24 hours of the cessation of snowfall, clear snow from around fire hydrants that are near your property, check with your neighbors regarding snow removal and direct sump pumps and downspouts away from hard surfaces so that water doesn't build up and freeze, creating slippery conditions on driveways, sidewalks or streets.

Sign up on the Hiawatha website (www.hiawatha-iowa.com) to receive notifications for snow emergencies!

- Vertical separations equal to three-fourths (3/4) inch or more
- Horizontal separations equal to one-half (1/2) inch or more
- Holes four (4) inches in diameter and missing full depth parts of sidewalk
- Excessive spalling and cracking
- Excessive dips and bumps in the sidewalk

Currently the Community Development Department receives the complaints concerning unsafe sidwalks. Our department verifies the complaint and sends notice to property owners regarding unsafe sidewalks requesting them to be corrected.

For defective sidewalks the City works with the owner to develop appropriate time frames for corrections. The City will assist property owners repairing unsafe sidewalks through our permitting and inspection processes. However, if the owner fails to fix the unsafe sidewalk the City has authority to repair the sidewalk and to assess the owner for the costs associated with the correction.

Preventive maintenance eliminates the need for additional city involvement through our complaint process. More importantly, it keeps our city safe. We encourage all property owners to maintain safe sidewalks as part of being a good neighbor in Hiawatha.






# Thank you Cedar Rapids Toyota!
