# What is a Roundabout?

On October 16, the Hiawatha City Council approved moving forward with the Tower Terrace Roadway Expansion design work to include a roundabout at Tower Terrace Road and North Center Point Road.

A modern roundabout is a circular intersection where drivers travel counterclockwise around a center island. There are no traffic signals or stop signs in a modern roundabout. Drivers yield at entry to traffic in the roundabout, then enter the intersection and exit at their desired street. Studies by the Federal Highway Administration have found that roundabouts can increase traffic capacity by 30 percent to 50 percent compared to traditional intersections. Roundabouts are designed to make intersections safer and more efficient for drivers, pedestrians and cyclists. There are two types of roundabouts: Single-lane roundabouts and multi-lane roundabouts.



As you approach a roundabout, you will see a yellow "roundabout ahead" sign with an advisory speed limit for the roundabout. Slow down as you approach the roundabout, and watch for pedestrians in the crosswalk. Continue toward the roundabout and look to your left as you near the yield sign and dashed yield line at the entrance to the roundabout. Yield to traffic already in the roundabout. Once you see a gap in traffic, enter the circle and proceed to your exit. If there is no traffic in the roundabout, you may enter without yielding. Look for pedestrians and use your turn signal before you exit, and make sure to stay in your lane as you navigate the roundabout.

## **Driving Multi-Lane Roundabouts**

In a multi-lane roundabout, you will see two signs as you approach the intersection: The yellow "roundabout ahead" sign and a black-and-white "lane choice" sign. You will need to choose a lane prior to entering the roundabout. You choose your lane in a multi-lane roundabout the same way you would in a traditional multi-lane intersection. To go straight or right, get in the right lane. To go straight or left, get in the left lane. More information on roundabouts can be found at iowadot.gov/traffic/roundabouts/roundabouts-in-iowa. Here are a few key things to remember about driving roundabouts:

- Yield to drivers in the roundabout
- Stay in your lane; do not change lanes
- Do not stop in the roundabout
- Avoid driving next to oversize vehicles

#### **Truck Traffic Benefits**

Roundabouts are designed with truck aprons, or slightly raised sections between the roads and the inner circle of the roundabout, which accommodate truck traffic.

#### **Snow Ordinance Reminder**

Our snow ordinance is in effect when the National Weather Service (NWS) predicts a snowfall in which three (3) or more inches of snow are expected. While the Snow Ordinance is in effect, there is no parking on any city street. Vehicles found parked in violation of this ordinance will receive a \$25 parking ticket and/or be impounded. During overnight snow removal operations, vehicles found in violation on City streets will be towed. The notice of declaration will be sent to all the local media including but not limited to: KGAN (Channel 2), KCRG (Channel 9) and KWWL (Channel 7). The declaration will also be posted on the City website, www.hiawatha-iowa.com. Sign up on the Hiawatha website to receive notifications for snow ordinance declarations to your cell phone or email. Your cooperation is appreciated.



#### **REMEMBER - Don't park in the street if:**

- The 24 hour (or less) prediction by the NWS is for three (3) or more inches of snow.
- Three (3) or more inches of snow has fallen and/or your street has not been cleared.

When in doubt about parking, just move your vehicle off the street. The City will NOT conduct snowfall clearing operations on all streets for a snowfall of less than two (2) inches. Sidewalks must be shoveled within 24 hours of the cessation of snowfall, clear snow from around fire hydrants that are near your property, check with your neighbors regarding snow removal and direct sump pumps and downspouts away from hard surfaces so that water doesn't build up and freeze, creating slippery conditions on driveways, sidewalks or streets

## The Sidewalks of Hiawatha - Part 3

Because the City of Hiawatha, and many of our residents, view sidewalks as an important asset to our community, the Council has directed staff to take actions to enhance our sidewalk maintenance program. This series of articles is intended to raise the awareness of our sidewalks and the value they hold in our community in order to encourage and promote sidewalk maintenance and sidewalk usage.



#### **Sidewalk Maintenance Problem:**

In November 2017 staff requested support to initiate a sidewalk maintenance program for Hiawatha due to a growing number of concerns and complaints. Council authorized an evaluation of Hiawatha's public sidewalk deficiency standard and a sidewalk study to determine the extent of the problem. These two components would allow staff to quantify and develop possible solutions based on new acceptable standards. Action was taken to amend Hiawatha Code Chapter 136 to a new standard. Tolerances for vertical and horizontal separations defining a "defective sidewalk nuisance" were increased to 1" and allowable slopes and dips were slightly increased. These changes aligned Hiawatha's standard with other area city standards.

ICAP; Hiawatha's liability insurance carrier, was enlisted to perform the assessment in the defined area between Miller Road and 10th street and between Boyson Road and Emmons. The area includes about six miles of street and 12 miles of sidewalk. (About 20% of the total sidewalks in Hiawatha) This is an area where complaints are regularly received. The study revealed 120 defects in the sidewalks in this area. Most of the issues were due to vertical separations of 1" or more:

Vertical separation only 77
Horizontal separation only 8
Holes/cracks/separations 35

The program photos also revealed 14 accessibility curb ramps with deficiencies. The ramps were not assessed for compliance to the Americans with Disability Act Accessibility Guidelines (ADAAG) but will require completion by our engineering or inspection departments familiar with the standards. This standard includes specific ramp width, slopes, and truncated warnings. Given the number of deficiencies found, staff recommended Hiawatha begin a sidewalk maintenance program. The goal is to maintain and improve our existing public sidewalks. The total estimated cost of making the repairs associated with this limited area of the City for the noted deficiencies (not including accessibility ramps) was \$85,000 using the calculation:

10 (average repair linear footage)

X 120 (the number of defects noted in the report)

X \$70 (estimated cost of sidewalk for each linear foot at 5' wide).

\$85,000 (estimated total cost of defects from the assessment)

This does not include recommended upgrades to the accessibility ramps excluded from the program. The assessment indicates the City of Hiawatha is not adequately addressing the sidewalk defects in our current policy which is solely complaint driven. As a result, defective sidewalks are detracting from the walkability and safety within our community. So what is the solution? Our next newsletter article will detail a proposal to proactively address these issues over a ten year period and beyond in an effort to preserve this valued asset.

# **Be Careful of Frozen Pipes this Winter**

Here at the Water Department we know the importance of having water available when you open the tap or flush a toilet. We also understand the frustration you experience when the water is not present. It's that time of year for water main breaks to occur. If you should see or suspect a water leak please report it to the Water Department at 319-393-5556. Or if it is after business hours please contact the non-emergency Police Department number 319-393-1212. We will promptly investigate your concern.

The Water Department wants to make sure our residents know what to do if or when this happens. When a water main break occurs it requires the Water Department employees to close down several water main valves to isolate the main and control the leak. We do our best to inform our customers when a water main break occurs. Many times these main breaks are emergencies or they occur after hours and our customers don't become aware of the leak until water is not available. Rest assured, the Water Department employees will be working diligently to find the source of the leak and correct the issue to re-establish water to your property in a timely manner. We appreciate your patience when a situation like this arises.

## Firefighters Host Chili Supper

Hiawatha Firefighters hosted their annual Chili Supper on Saturday November 2 at the Hiawatha Fire Station. Firefighters served more than 25 gallons of chili to more than 800 visitors. Money raised during the Chili supper goes to support the Fire Department through the purchase of equipment and support to the members. Most recently, the money from past Chili Suppers was used to equip a John Deere Gator (all-terrain vehicle) with emergency lights, pump, water tank, and cab. The Gator was purchased with a grant from Firehouse Subs. "The businesses and citizens of Hiawatha are very supportive," said Paramedic/Firefighter Micah Powell. "The support we receive from the community has been fantastic. A lot of donors gave to this event." Powell was the chairperson of this year's event. The supper, which is held annually on the first Saturday in November, raises money for the Hiawatha Firefighters Association. The association is a 501c3 organization made up of members of the Fire Department. The association's purpose is to act as the fundraising arm of the Fire Department and to support the department and the members.

## Firefighters Score Big with MDA Drive

Hiawatha Firefighters had another record year collecting for MDA this year. Members of the Fire Department hit the street in early September, boot in hand, to collect money to donate to MDA. This year, several local businesses donated services or money via the Hiawatha Fire Department including Sam's Club, CCB Packaging, McGrath, Farmers State Bank, Big 10, and Oscar's. Altogether, firefighters raised more than \$17,000. Since 2011, Hiawatha Firefighters have raised more than \$117,000 for MDA.

#### **October was Fire Prevention Month**

Hiawatha Firefighters had a busy month in October with a variety of fire prevention activities. Hiawatha visited with 230 preschoolers at Little Lambs Preschool, Hiawatha Day School, Hand in Hand Daycare, and Mother Goose. Firefighters demonstrated the gear they wear, helping the kids remember that firefighters may look a little scary, but they are friends. Firefighters also told the students that | firefighters have a job to go inside and fight fire, but that kids have a job to get out and stay out if there is a fire. Finally, they are taught that lighters and matches are tools, not toys. The firefighters also visited Nixon and Hiawatha elementary schools. Firefighters showed off the fire truck, something the kids are always interested in. They also talked about smoke detectors, having exit plans, getting low to avoid smoke, and sleeping with the door closed. The Red Cross and the Hiawatha Fire Department volunteers reached out across the city October 26 to help replace smoke detector batteries for those who can't do so themselves. Firefighters visited 45 homes in Hiawatha, and replaced about 200 smoke detector batteries. A few homes had smoke detectors that were more than 10 years old. They replaced 17 smoke detectors in all. Just a reminder that fall is a good time to replace your smoke detector batteries and replace the detectors if they are more than 10 years old. Firefighters will help residents who cannot change the batteries themselves due to physical difficulty. If you need assistance with a smoke detector call 319-393-4180.
