The City of Hiawatha strives to find methods to increase our government's transparency and be more open to the public in our daily practices. The Mayor, City Council and staff work hard to be crystal clear to the public of their actions. We do this in several ways with our City website being our primary source for information. Through our newly redesigned website we provide easy access to government records, featuring notices to upcoming city council meetings with detailed agendas and from those meetings provide readable minutes. Council packets, strategic plan and capital improvement plan are accessible on our website by clicking on the Government tab/City Council/City Council Documents link on the right hand side of page. By clicking on the Departments tab/Policy and Admin citizens can access our annual audit and request public records by emailing your request to the City Clerk or City Administrator. Most recently you will find a "Stay Current" section at the bottom of all website pages. Click on the "Get Alerts" button to be the first to know about snow emergencies, projects, leaf pick up, deadlines, events, announcements and more! You can subscribe to both email and text alerts. An additional way to stay connected to the latest City information is by liking our City of Hiawatha, Iowa Facebook page.

The other avenues we use to keep citizens informed is through our Hiawatha Insights monthly newsletter containing information on our infrastructure projects, upcoming events and much more. Our council meetings are held every first and third Wednesday of each month at 5:30 PM. Theses meetings are open to the public. Our council meetings are also recorded and can be viewed on the second and fourth Wednesday of every month on Mediacom Channel 18 at 7:00 PM or ImOn Channel 4 from 6:00 - 7:30 PM. Lastly, our doors are always open along with easy access to mayor, council and staff with online access to emails and phone numbers. We welcome your questions, comments and participation. Our city hall hours are from 8:00 AM - 5:00 PM, Monday - Friday or by appointment.

Transparency is a process. We understand transparency promotes accountability and provides opportunities for our residents to be better informed about what is going on in our community. As technology improves and funding becomes available, we will open up new avenues to help connect the public to our government records and finances. ## Boyson Road Trail Extension Project - Project Cost Estimate Approximately \$100,000.00

Hiawatha City Council has authorized a design contract to prepare plans and specifications for the extension of

the Boyson Road Multi-Use Trail from 12th Avenue to 15th Avenue. The proposed extension is the next project in the continued effort to develop a trail system along the south side of Boyson Road from Edgewood Road to the Cedar Valley Nature Trail east of North Center Point Road. The trail bid package allows for the construction of this extension yet this fall. It is anticipated that construction can begin mid-October.

The project will be funded with the Capital Project Funds.

## North Center Point Road/Emmons Street/Robins Road Intersection Improvement Project Phase II -To Continue Through 2017 - Project Cost \$2,813,000

Hiawatha awarded a contract to Rathje Construction Inc. from Marion to reconstruct the existing intersection of North Center Point Road/Emmons Street/Robins Road. This project will move the intersection approximately 100 feet to the northwest. Rathje will reconstruct approximately 400 feet of North Center Point Road to south of Fisher Street.

Temporary pavement repairs have been completed in order to open all streets to traffic this fall. The project will continue starting spring of 2017 and will be completed in the fall of 2017. Contact the Engineering Department at cityengineer@hiawatha-iowa.com with any questions.

The project is funded with Capital Projects Funds, LOSST funds and Water Revenue Funds. Project completion date is November 2017.



## **Snow Ordinance Reminder**

Our snow ordinance will be in effect when the National Weather Service (NWS) predicts a snowfall in which three (3) or more inches of snow are expected. While the Snow Emergency is in effect, there is no parking on any city street. Vehicles found parked in violation of this ordinance will receive a \$25 parking ticket and/ or be impounded. During overnight snow removal operations, vehicles found in violation on City streets will be towed. The Snow Emergency declaration will be sent to all the local media including but not limited to: KGAN (Channel 2), KCRG (Channel 9) and KWWL (Channel 7). The declaration will also be posted on the City website, www.hiawatha-iowa.com. Your cooperation is appreciated.

## **REMEMBER - Don't park in the street if:**

- The 24 hour (or less) prediction by the NWS is for three (3) or more inches of snow.
- Three (3) or more inches of snow has fallen and/or your street has not been cleared.

When in doubt about parking, just move your vehicle off the street.

Also, the City will **NOT** generally conduct snowfall clearing operations on all streets for a snowfall of less than two (2) inches. This policy remains unchanged from prior years. Please remember: sidewalks must be shoveled within 24 hours of the cessation of snowfall, clear snow from around fire hydrants that are near your property, check with your neighbors regarding snow removal and direct sump pumps and downspouts away from hard surfaces so that water doesn't build up and freeze, creating slippery conditions on driveways, sidewalks or streets.

# GILL"S Guide to Healthy Surface Water EMPTY YOUR POOL AND SPA WITH CARE, Part One

This is it - the end of the summer and time to empty the pool until next year. Chlorine and other chemicals used to keep your pool or spa clean causes BIG problems for us fish and other acquatic life. ALL it takes is a FEW steps to not comprimise or pollute the "air" (i.e. water) we breath:

- Allow pool / spa to sit at least seven days without adding chlorine or other chemicals chlorine content should be 0.1 milligrams per liter.
- Ensure the pH of the pool / spa water is between 6.5 and 8.5.
- Drain water through at least 15 feet of a grassy landscape first (i.e. not directly onto concrete) to allow remaining chemicals to disappate before reaching the storm drain.
- Keep the flow of water low (shoot for 700 gallons per hour = 12 gallons per minute or so) to prevent erosion and having to fix the landscaped area later.

# GILL"S Guide to Healthy Surface Water EMPTY YOUR POOL AND SPA WITH CARE, Part Two

### A SPECIAL NOTE FOR SALTWATER POOLS AND SPAS AND BACKWASH FILTER SYSTEMS...

Hey, here in Iowa we are freshwater fish - saltwater is deadly to acquatic life. You must discontinue the addition of salt as you ready to empty the pool or spa. Like the chlorine pool, test to ensure chlorine is below 0.1 mg/l and the pH is between 6.5 and 8.5 before draining commences onto a grassy landscape that is salt-tolerant AND able to absorb all water.

Water from backwash filter systems is not allowed in the storm sewer system, under any circumstances. This water should be directed to the sanitary system through a drain in your home or discharged to the lawn.

Word has it, failure to follow these guidelines is considered an illicit discharge, under most City codes and could result in a fine.

On Monday, July 18, Alex Studt was mowing grass when he was stung by a bee. Having had previous reactions to bee stings, Alex took Benadryl, told his 16 year old son Dalton to get in the car and began driving

toward the St. Luke's Urgent Care on Boyson Road. As they approached Center Point Road and East Clark Street still driving, Alex became upresponsive. Unconscious and still behind the wheel, Alex was still pushing on the accelerator but not steering.

Dalton, sitting in the passenger seat, began blowing the horn and steering the car. Dalton was able to turn the car from Clark Street north on Center Point Road. Witnesses reported the car veered into oncoming traffic. Dalton then went through the red light at Emmons Street, still blowing the horn and steering from the passenger seat, his dad unconscious in the driver's seat. As they approached the area of GoDaddy, Dalton, using one hand to steer, was able to use the other hand to push on the brake and bring the car to a stop against the curb. He found his dad's phone on the floor and called 9-1-1.

Certainly, without Dalton's fast thinking and controlling the vehicle, lives could have been lost. The vehicle could have easily struck another moving vehicle, a pedestrian, or even a stationary object, causing further injury or even death. Dalton's actions that day clearly saved the life of his dad and prevented the loss of additional life.

For this reason, the Hiawatha Fire Department and Hiawatha Police Department recognized Dalton for his actions at the September 7 Council Meeting by presenting him a life saving award.

## Hiawatha Fire Department Awarded Assistance for Firefighters Grant

The Fire Department has received notification from the Federal Emergency Management Agency that we have been awarded an Assistance for Firefighters Grant. The purpose of the grant is to enhance firefighter safety and to improve operations by providing personal protective equipment. Specifically, we are going to replace our aging self-contained breathing apparatus ("Air Packs"). We wear the air packs when we go into dangerous atmosphere. The existing packs are 20 years old and most do not comply with current standards. This is important considering that failure of a SCBA can be fatal for the firefighter wearing them. In addition, we are replacing our breathing air compressor. The approved amount of the grant project is \$275,320, Federal share is \$262,210 and the city's share is \$13,110 or 5 percent of the Federal Share. The fire department will be using LOSST funds for the city share. Previously, these items were EFIGHTE scheduled for replacement in several years, with the money coming from the Capital

scheduled for replacement in several years, with the money coming from the Capital Improvement Fund. The most important factor is that the grant will provide equipment to keep the firefighters safe. Additionally, the grant will free up Capital funding for other projects. It is expected that the new equipment will arrive in early spring.

## Hiawatha Firefighters Raises More Than \$15,500 During 2016 Fill the Boot Campaign

Hiawatha Fire Department was one of the top departments in the state for collecting for the Muscular Dystrophy Association. This year firefighters working at street corners, stores and farmers markets collected more than \$15,500. As of "Press time," that places Hiawatha Fire third in the region, behind only two larger paid departments who allowed on duty firefighters to collect. Cedar Rapids collected more than \$32,000 and Waterloo more than \$20,000. Every hour spent and every penny collected by Hiawatha Fire was done so by volunteer firefighters and their families and friends! We could not have done it without the support of the local community. The com-

the support of the local community. The combined totals of Hiawatha and Cedar Rapids, (more than \$48,000) demonstrates the caring nature of the people in the Hiawatha area.
