Hiawatha Public Library Unveils Its Worth with Library Calculator

HIAWATHA, Iowa—The Hiawatha Public Library (HPL) completed its fiscal year on June 30, 2017, and recently finished the data gathering for that year's usage. Patrons from Hiawatha, northeast Cedar Rapids, Robins, rural Linn County and beyond used services and materials from HPL July 2016 through June 2017 valued at \$4,484,403.

The valuation is based on the "Library Use Value Calculator," which uses average

prices of materials and services if users had to purchase them instead of utilizing them through HPL. Individuals can calculate their own value use as well by going to ILoveLibraries.org/What-Libraries-Do/Calculator.

"This dollar value reinforces what we already knew—that Hiawatha Public Library is well used," said Jeaneal Weeks, library director. "And for those who don't use the library, I encourage them to consider the items and services they pay for that we can do for free, and think about what they could be saving."

The calculator looks at traditional, audio and electronic books for all ages, periodicals, movies, music, meeting room use, programs attended and databases accessed among other services.

"What this calculator doesn't show is the residual economic impact Hiawatha Public Library has on economic development," said Kyle Kunz, chair of Hiawatha Economic Development Corporation and partner at Honkamp Krueger & Co. "Primarily through the literacy and learning gained by patrons, workforce development and small business support, the library has a bigger effect on the community this way than most realize. The library also is a destination for people, bringing them into our community where they then stop at other places and make purchases."

HPL is planning a remodel and addition to help foster the growth it's seen since it moved to its current location in 1998. Circulation alone in that time has increased 196 percent. "Our collection is less than the average for libraries its size in Iowa, yet its circulation is the highest for libraries its size. An average of 500 people per day visit us," said Weeks. "We have the highest circulation of libraries per capita in the metro area and one of the highest in the state, yet we're one of the smallest structures in our library class despite this. We invite anyone to come in for a tour-see what we have to offer and the need for additional space."

The project will renovate the existing 8,543 square-foot structure and expand the library by another 13,457 square feet at the library's central location with a cost of \$4.133 million. To fund the project, \$1 million is designated from existing local option sales and service tax income. Another \$2 million will come from donations. The rest will come through a \$1.2 million city bond referendum on the ballot November 7, which Weeks points out does not call for an increase in taxes. "It is just state law that it has to go to vote," she said.

The expansion project has been planned for and is in the City of Hiawatha's current Capital Improvement Plan, structured to allow for no additional tax burden on the citizens of Hiawatha, Weeks said.

"The passing of the bond provides the residents of Hiawatha with an updated, expanded library to better serve the community with no additional tax dollars since it's already in the city budget," said Weeks "The project is a public-private partnership; a project to benefit all our city, our children, our patrons, our businesses and the greater community."

HPL kicked off phase one of its capital campaign at the end of June, aiming to raise \$1 million by the November vote. As of mid-September, volunteers had raised nearly \$730,000. Phase two of the campaign also has a \$1 million goal and will begin after the November vote.

Snow Ordinance Reminder

Our snow ordinance is in effect when the National Weather Service (NWS) predicts a snowfall in which three (3) or more inches of snow are expected. While the Snow Emergency is in effect, **there is no parking on any city street**. Vehicles found parked in violation of this ordinance will receive a \$25 parking ticket and/or be impounded. During overnight snow removal operations, vehicles found in violation on City streets will be towed. The Snow Emergency declaration will be sent to all the local media including but not limited to: KGAN (Channel 2), KCRG (Channel 9) and KWWL (Channel 7). The declaration will also be posted on the City website, www.hiawatha-iowa.com. Your cooperation is appreciated.

REMEMBER - Don't park in the street if:

- The 24 hour (or less) prediction by the NWS is for three (3) or more inches of snow.
- Three (3) or more inches of snow has fallen and/or your street has not been cleared.

When in doubt about parking, just move your vehicle off the street.

City will **NOT** conduct snowfall clearing operations on all streets for a snowfall of less than two (2) inches.

Sidewalks must be shoveled within 24 hours of the cessation of snowfall, clear snow from around fire hydrants that are near your property, check with your neighbors regarding snow removal and direct sump pumps and downspouts away from hard surfaces so that water doesn't build up and freeze, creating slippery conditions on driveways, sidewalks or streets.

Sign up on the Hiawatha website (www.hiawatha-iowa.com) to receive notifications for snow emergencies to your cell phone or email.

Park restrooms will be closed at the end of October weather permitting. There will be porta potties located at Clark and Guthridge Park November 1, 2017 through April 1, 2018.

North Center Point Road/Emmons Street/Robins Road Intersection Improvement Phase II Starts Final Stage



The last phase of the Emmons/Robins/North Center Point Road intersection reconstruction project is now underway. The final stage of the project, the Robins Road repaying, has started with the completion date of the project scheduled for November 1st. Robins Road was closed Monday, September 11, 2017 with a detour route established on North Center Point Road and Boyson Road. Access to all businesses will be maintained.

The work includes a new traffic signal, new street lights, new bike trail, and landscaping along the curbs and sidewalks. A ribbon cutting ceremony will be scheduled prior to opening the entire project.

Boyson Road Capacity Improvement Project at I-380



Edgewood Road Grading and Culvert Project - Tower Terrace Road to County Home Road

The Edgewood Road grading and culvert project has started with contractor Peterson Construction Company from Reinbeck, Iowa. This phase I project includes either the extension or the replacement of the existing culverts that will accommodate a new 30 foot pavement surface. This phase of the project will be completed this fall. The schedule is to complete the phase II project, new paved roadway, by November 2018.

Hiawatha Police Conduct ALICE Training at Hiawatha Care Center

On Friday September 15th Police Officers from the Hiawatha Police Dept assisted staff from the Hiawatha Care Center with their yearly in service training with focus being an ALICE trained facility. Over 150 staff members participated in (ALICE) Alert Lockdown Inform Counter Evacuate and is a simple yet comprehensive system of giving people options during an active shooter or armed intruder event.



Throughout our country there have been countless stories of violence at our schools, places of employment, businesses, malls, churches, and government buildings. These acts of violence occur randomly with no rhyme or reason and we are not immune from it. ALICE training is now as important to do as fire and tornado drills. During the training the staff members watched a video displaying the ALICE principals before participating in real life scenarios. The staff did a great job learning "ALICE" and putting to use what they had learned.

We're Ready for the Next Steps - 2018 Housing Fund Grant Rehabilitation Program

Housing Rehabilitation surveys are complete ECICOG has the designated area is south of West Clark Street to Blairsferry Road and then from 4th Avenue to our east city boundary lines to C Avenue meets the determined the low to moderate income (LMI) levels.

We're ready for the next steps in our housing rehabilitation program process. Now that we know this area meets the LMI criteria we are ready to see how many owner-occupied homeowners are interested in the possibility of obtaining housing rehabilitation assistance. For the city to move forward with such an application we need to have at least six (6) owner-occupied homeowners whom are interested in completing a housing rehabilitation application and meet the LMI criteria to move forward with an application.

The Iowa Economic Development Authority (IEDA) 2018 Housing Fund Grant's application is due January 2018. The owner occupied housing rehabilitation is a grant awarded to a city through a competitive application process that assists low to moderate income (LMI) homeowners with repairs on their property to meet minimum housing standards and address lead hazard concerns. The grant would provide an owner-occupied homeowner five-year forgivable loan in the amount of \$24,999 in general repairs and an additional \$7,500 for lead reduction work if necessary.
